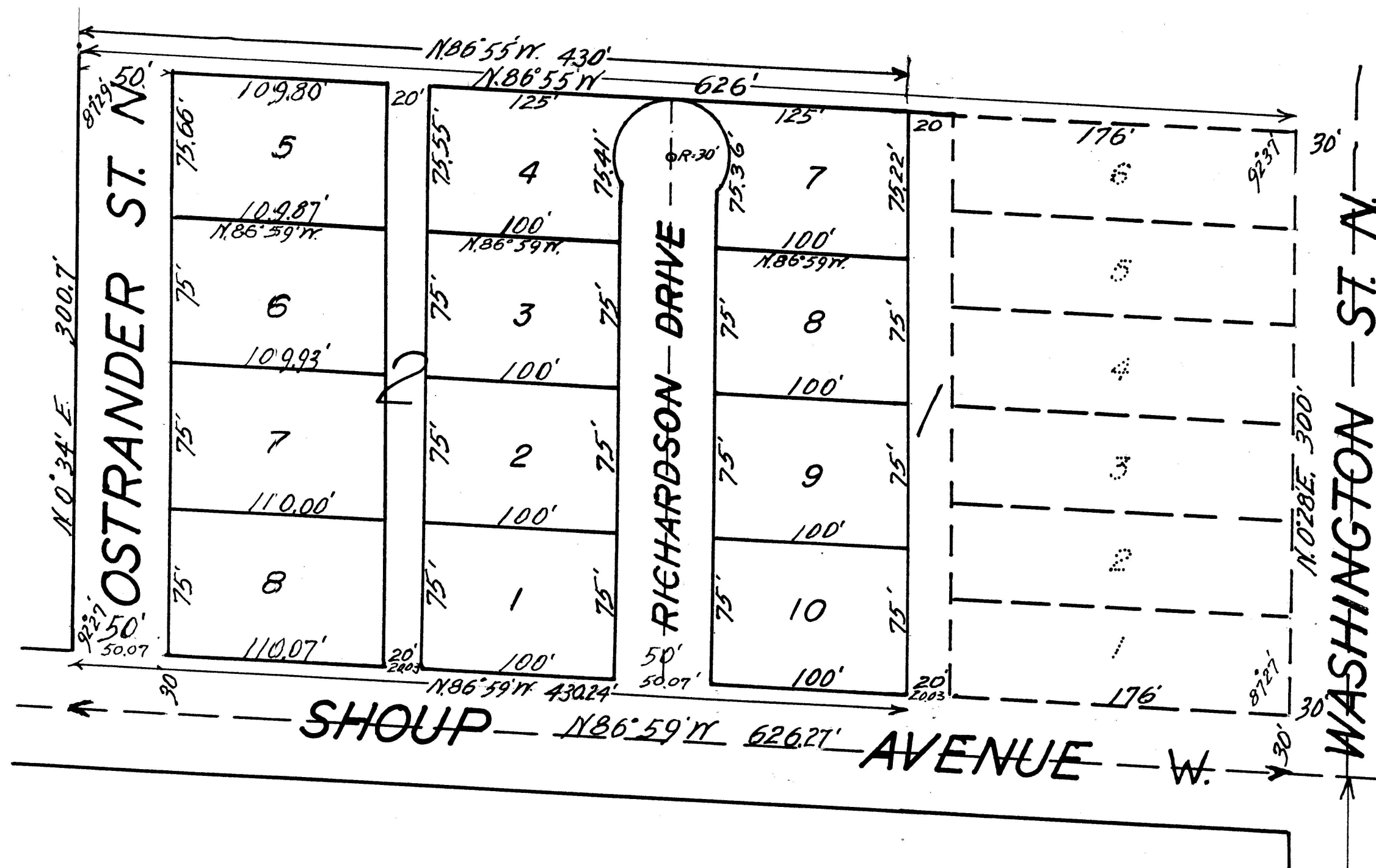




DEDICATION

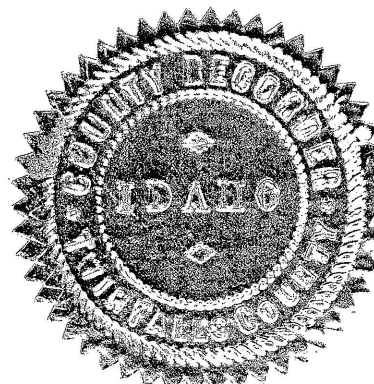
