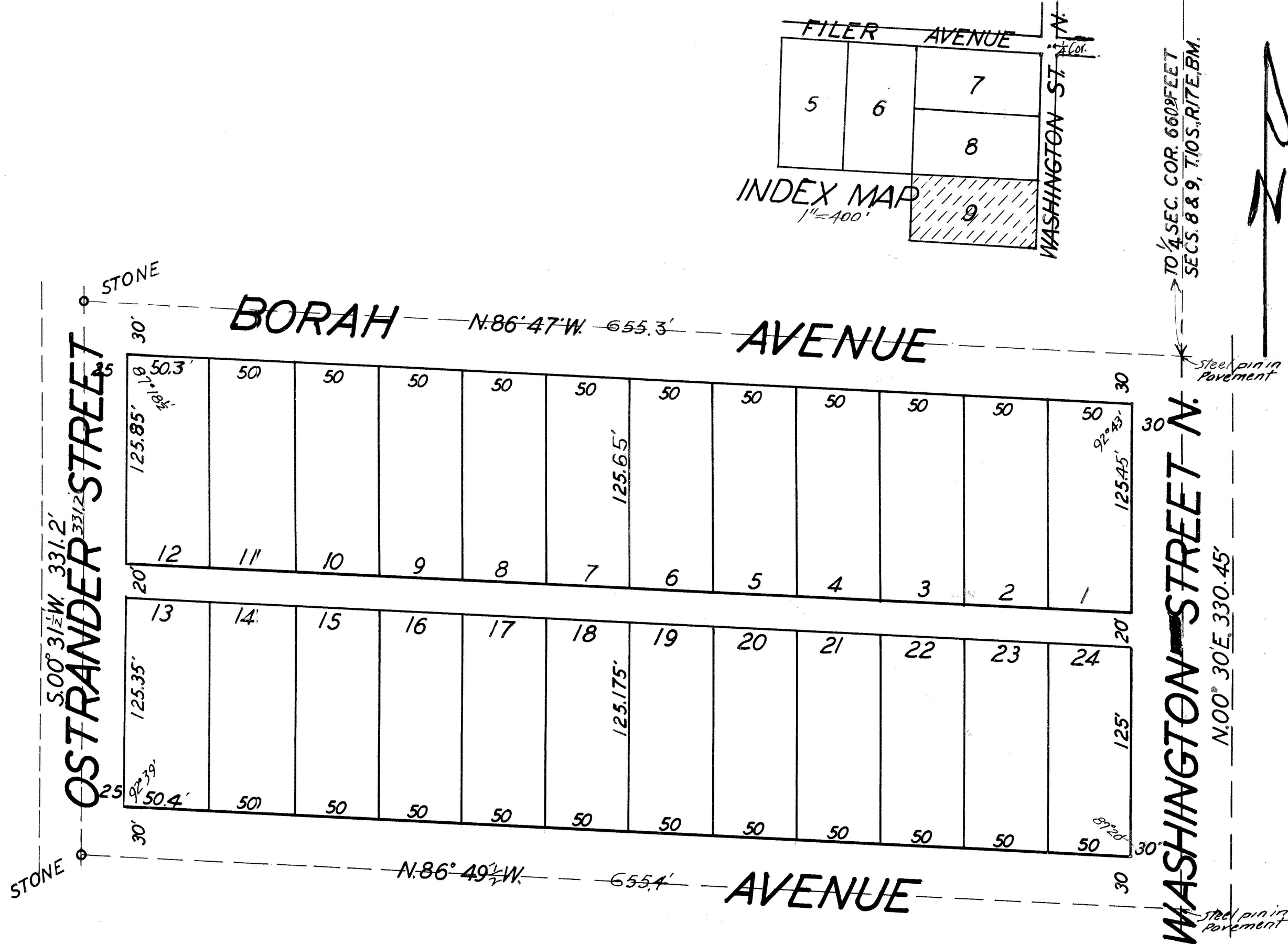




○ INDICATE LAVA STONE MARKER
