KNOW ALL MEN BY THESE PRESENTS: That we, HARRY W. BARRY, and HARRIET S. BARRY his wife, being the owners of the lands herein described, do hereby certify that the following is a true and correct description of the lands included in the BARRY'S SUBDIVISION, which are represented on the above plat, said lands are described as being that unplatted portion of the City of Buhl, Idaho, described as Tax Nos. 112 and 325, the latter being part of former Tax No. 108, all in the NW 1/4 of Sec. 36, T. 9 S., R. 14 E. 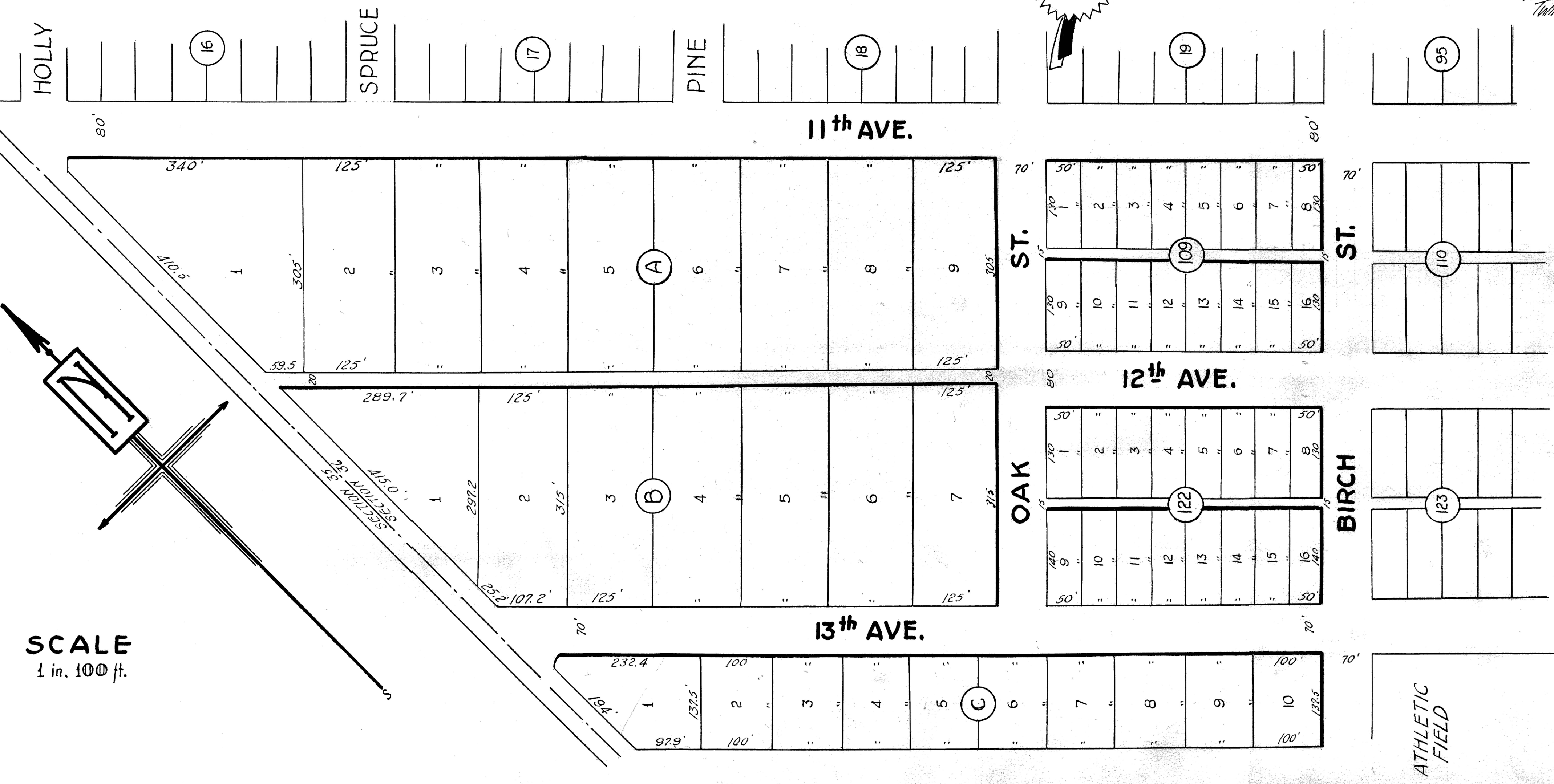
