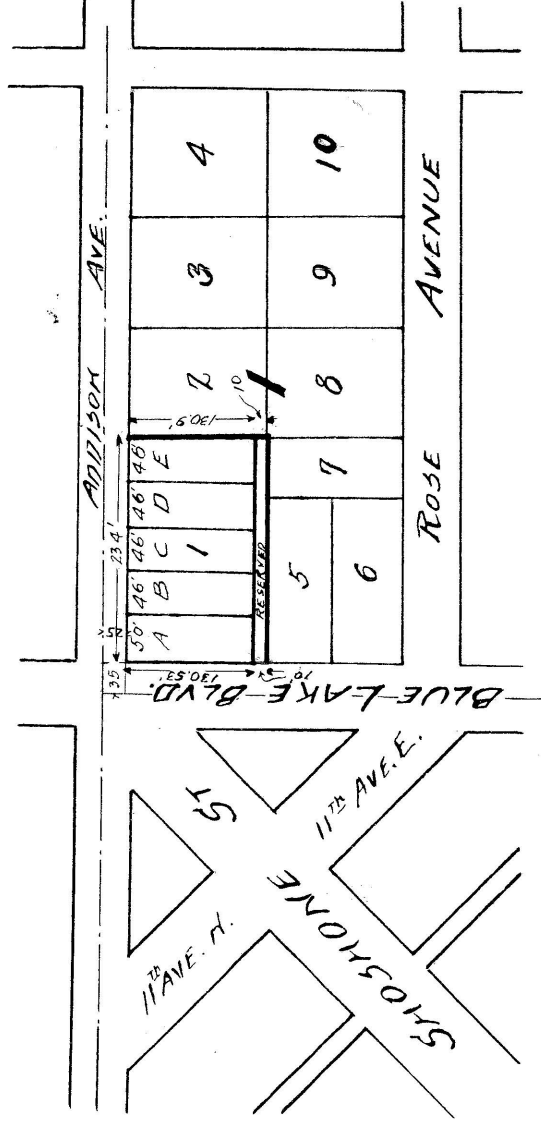


BARTLETT'S SUBDIVISION LOT 1, BLOCK 1, JONES ADDITION TWIN FALLS, IDAHO
