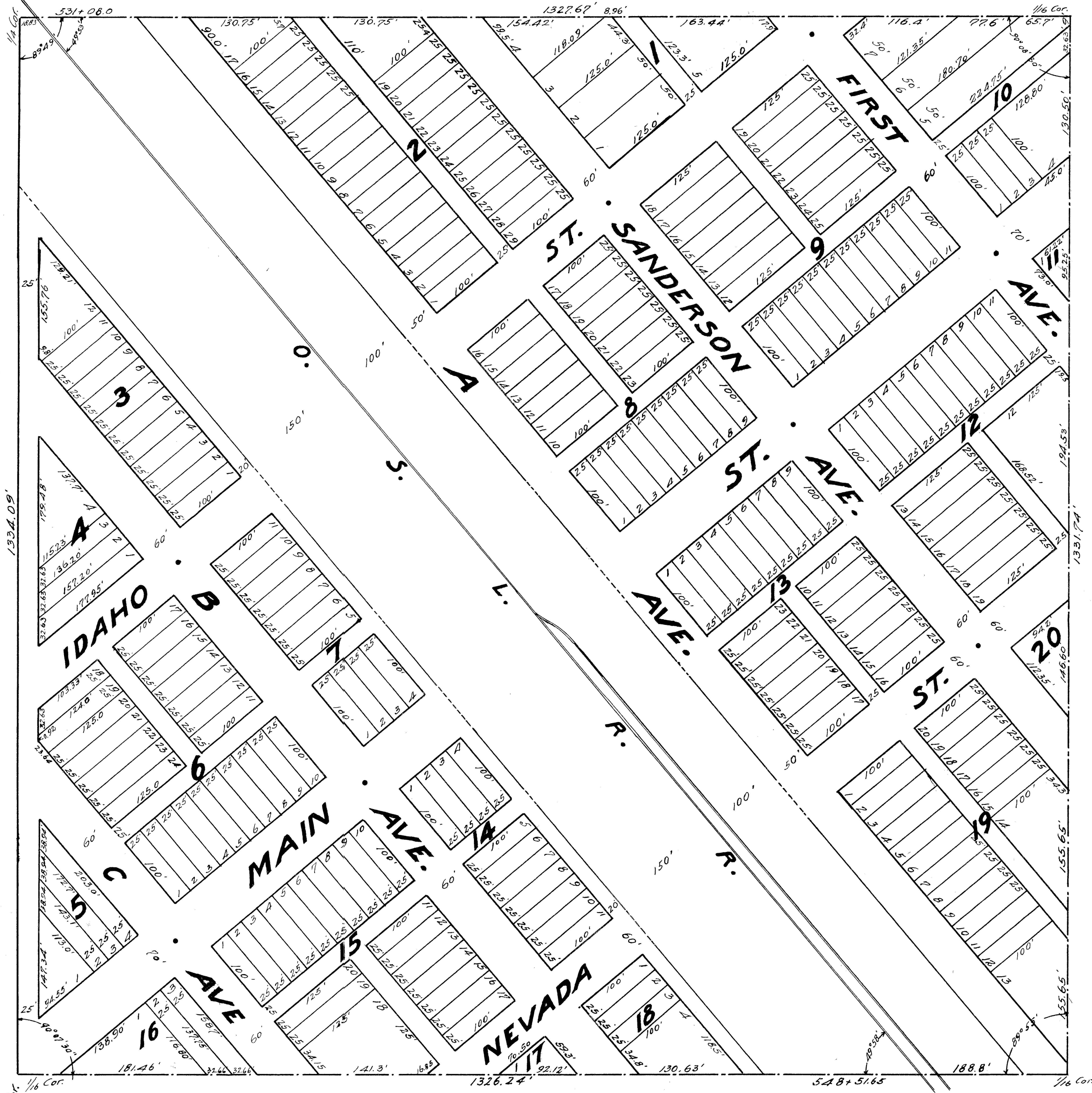


MAP OF BERGER, IDAHO. TWIN FALLS CO.

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, do hereby certify that the following is a true and correct description of the land included in Berger Township, which is included herewith, said land being known and described as the Northwest one quarter of the Southwest one quarter of Section 16 Township 11 South Range 16 East Boise Meridian, Idaho. And I do further certify that it is my intention to include the same in said plat thereof, and that in consideration of the filing of said plat by the County Recorder of Twin Falls County, Idaho, and the acceptance by the public of said streets shown on said plat do hereby give and grant to the public, forever, in fee simple, such portion of said premises platted as are on said plat set aside for streets and alleys for public use forever.
