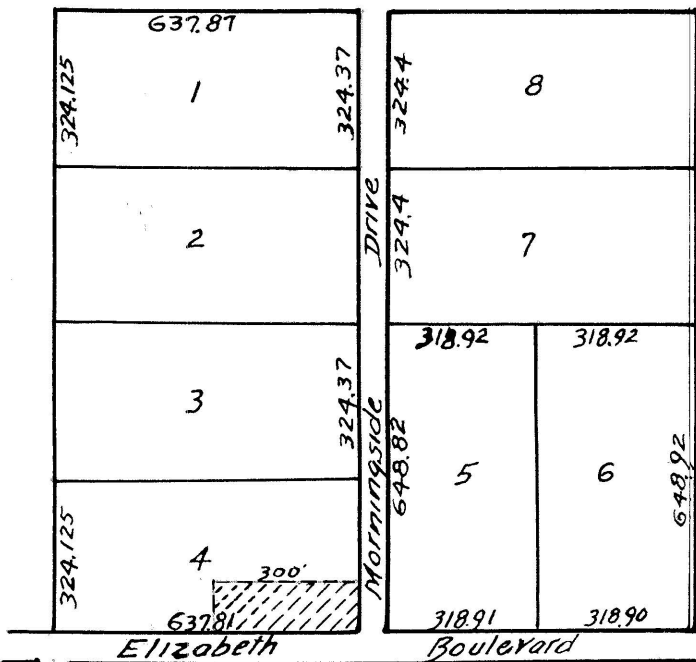


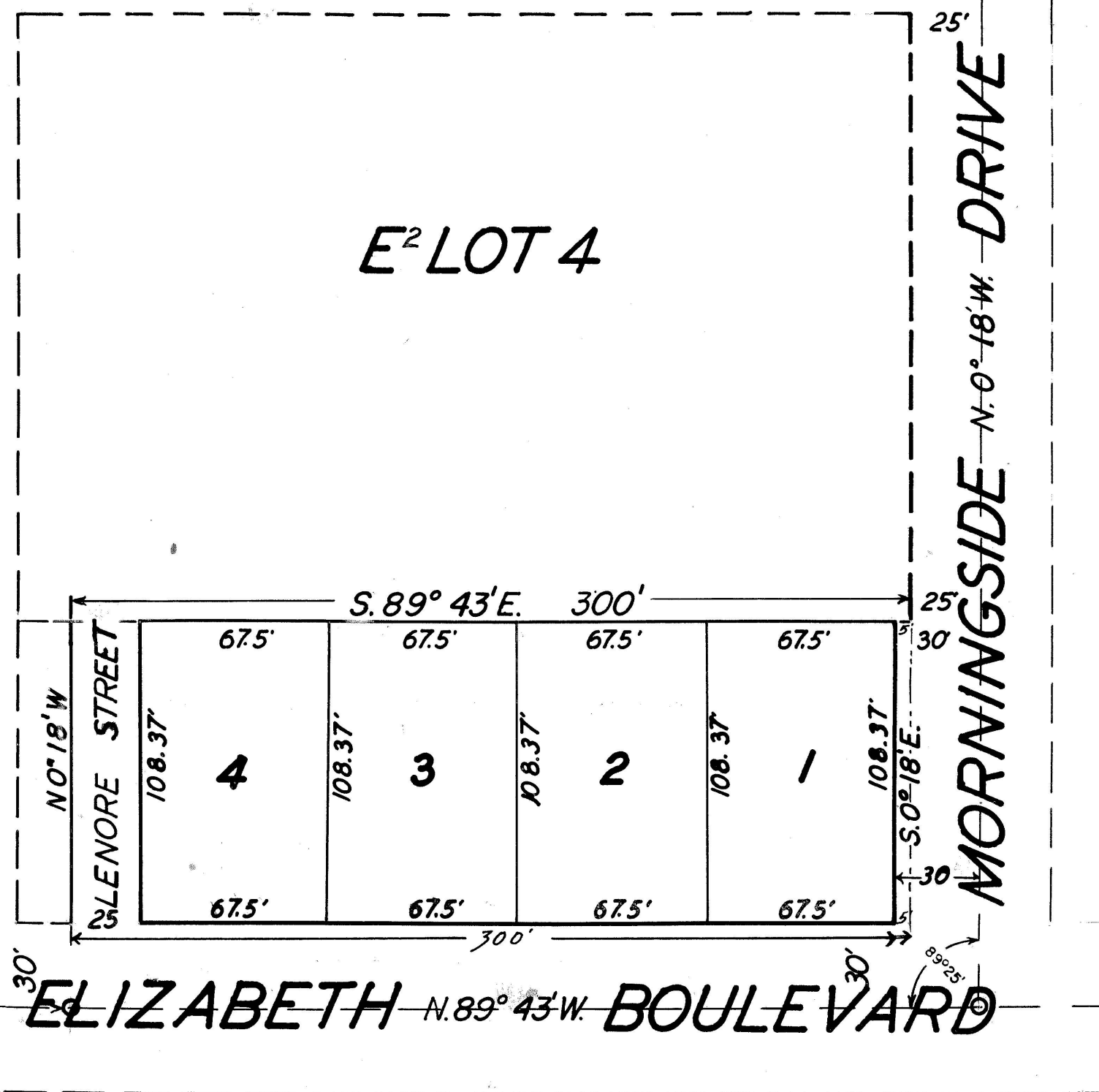


INDEX MAP HILL TRACT NO. 2.

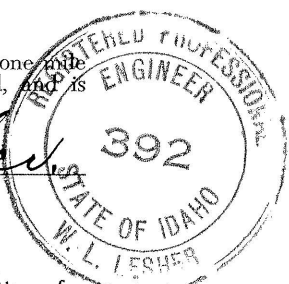
