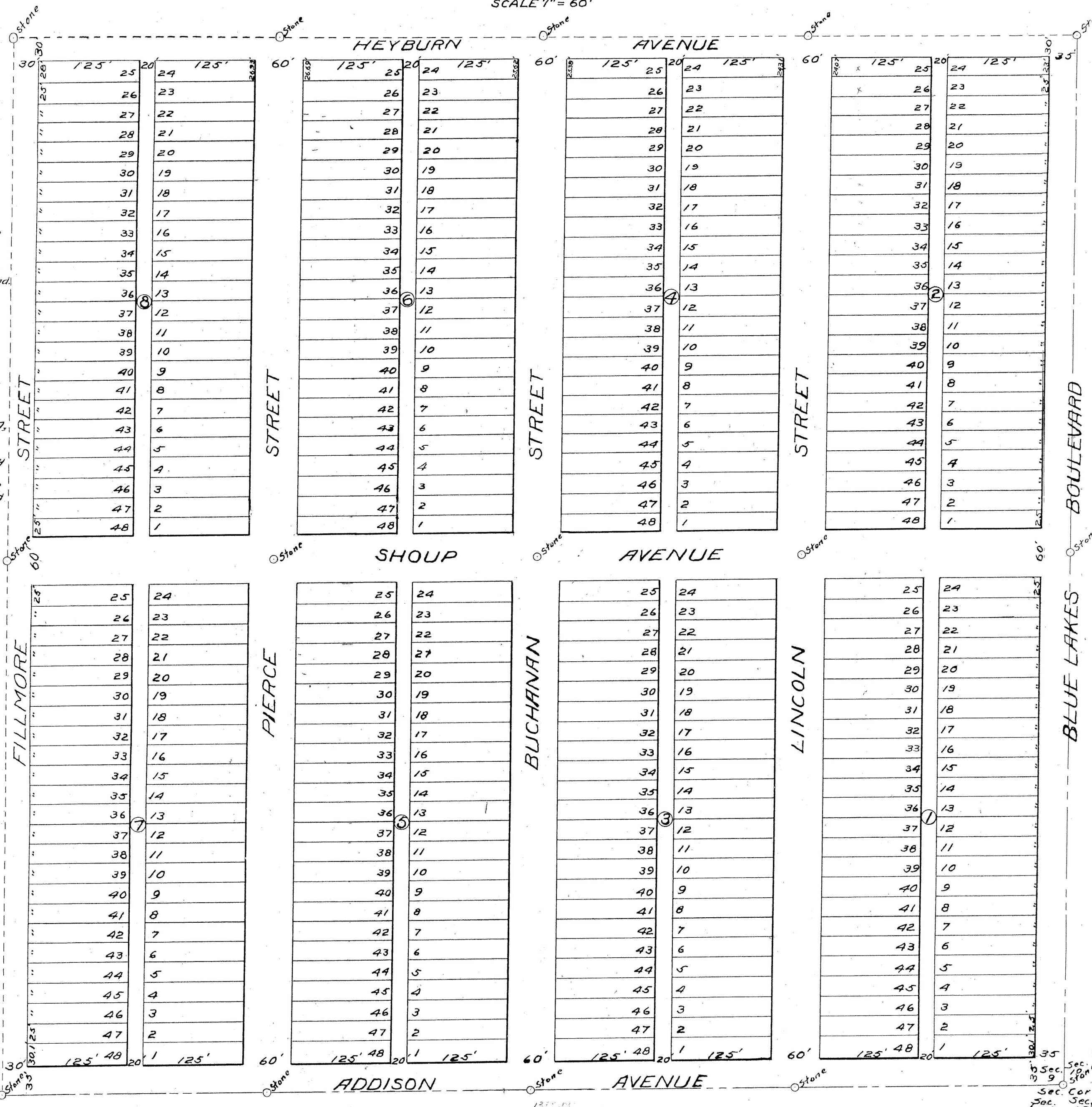


PLAT OF
