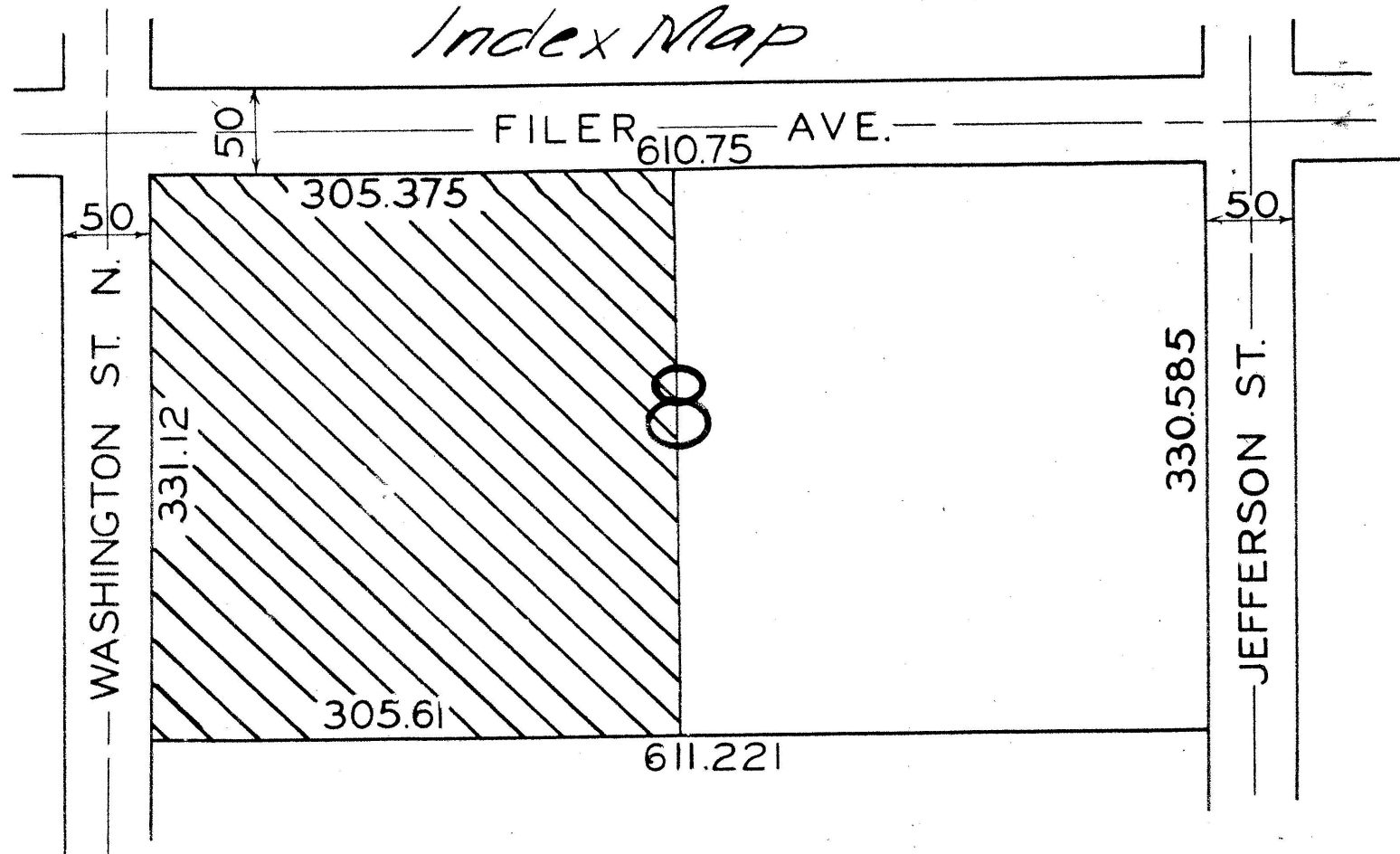


Index Map
