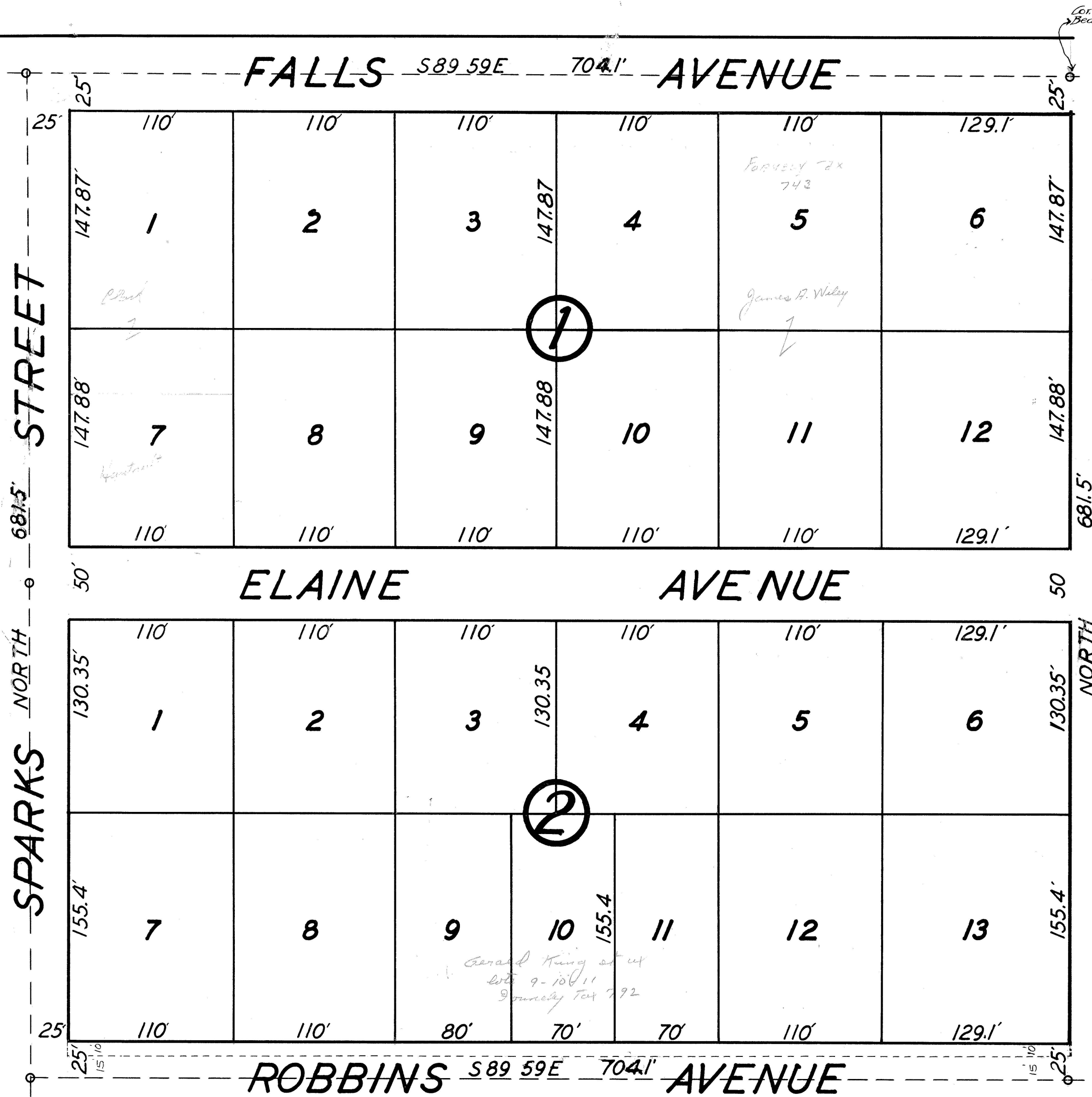




DEDICATION
