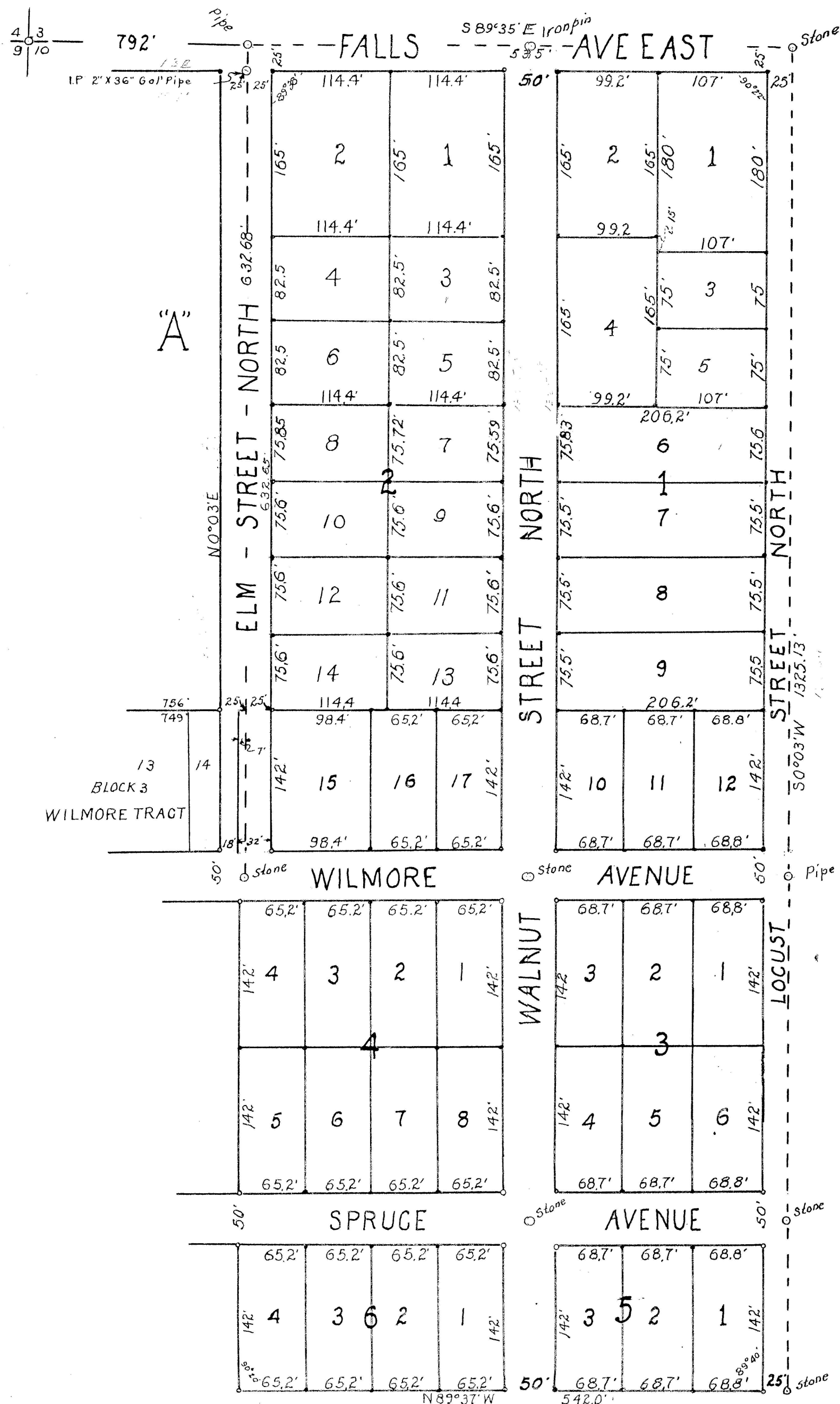


CRAWFORD ADDITION
