

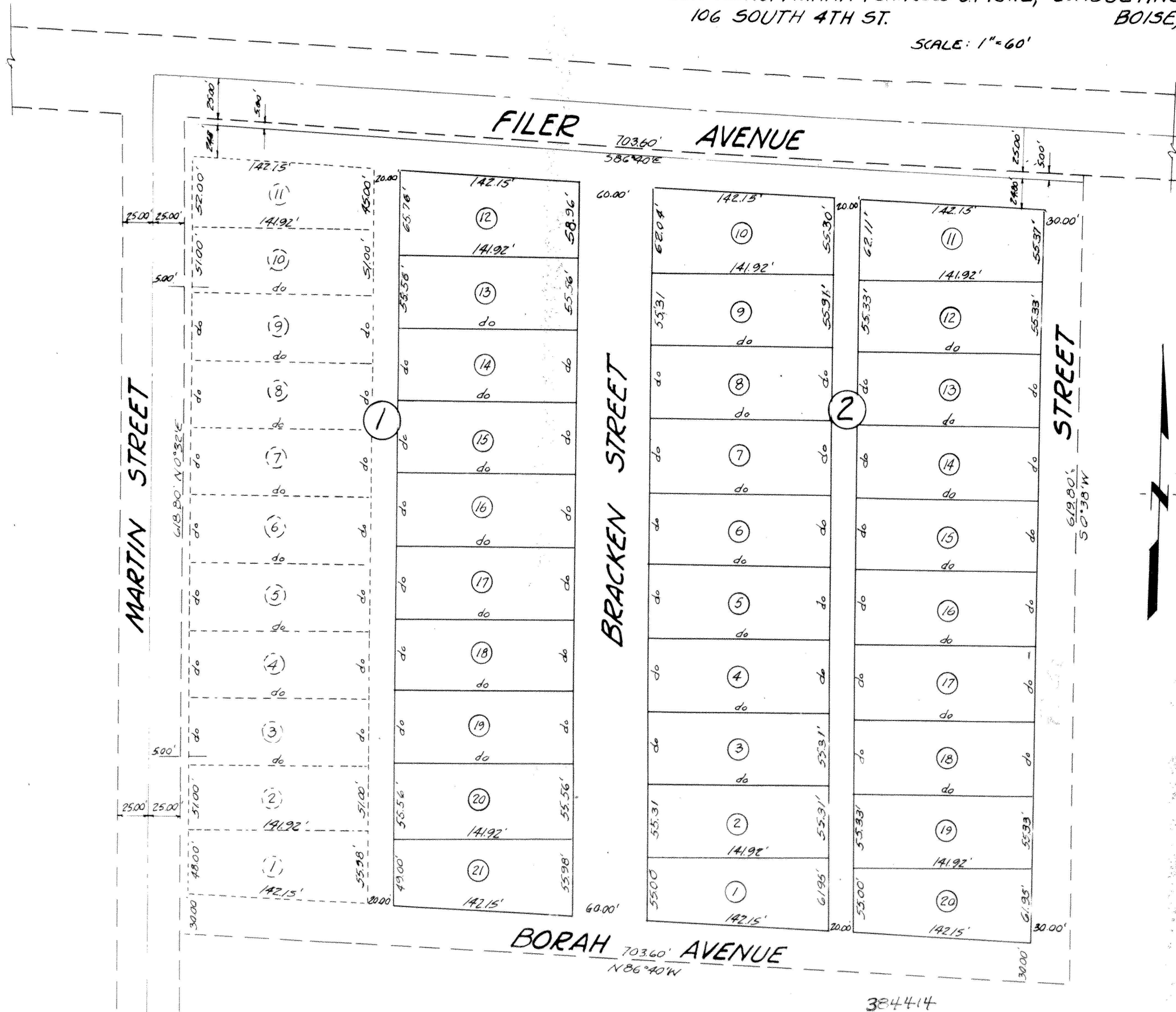
SECOND AMENDED PLAT TO CROTHERS SUBDIVISION
