We hereby donate all the streets and alleys, "as shown on the accompanying plat" to the use of the public forever.

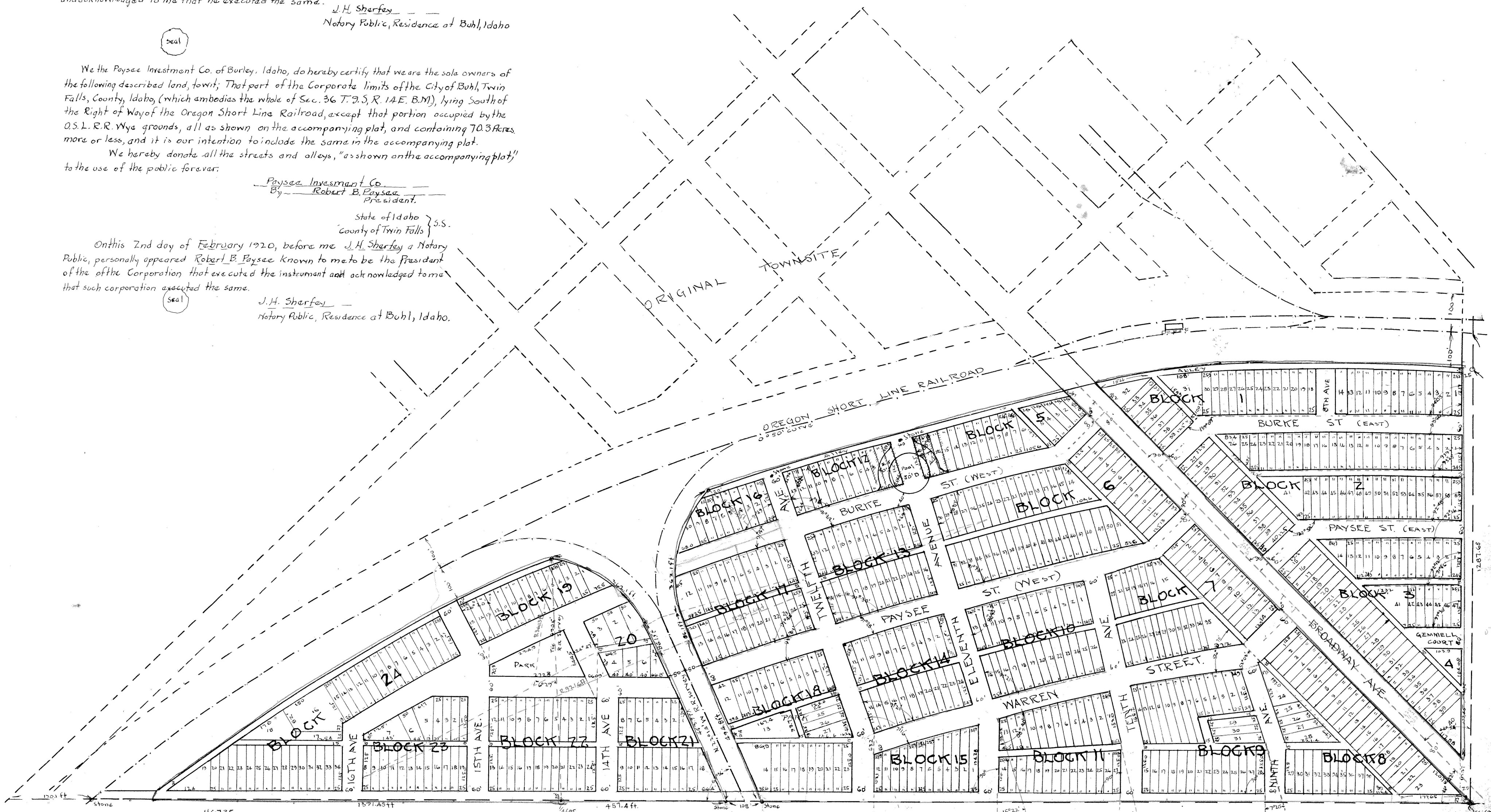
