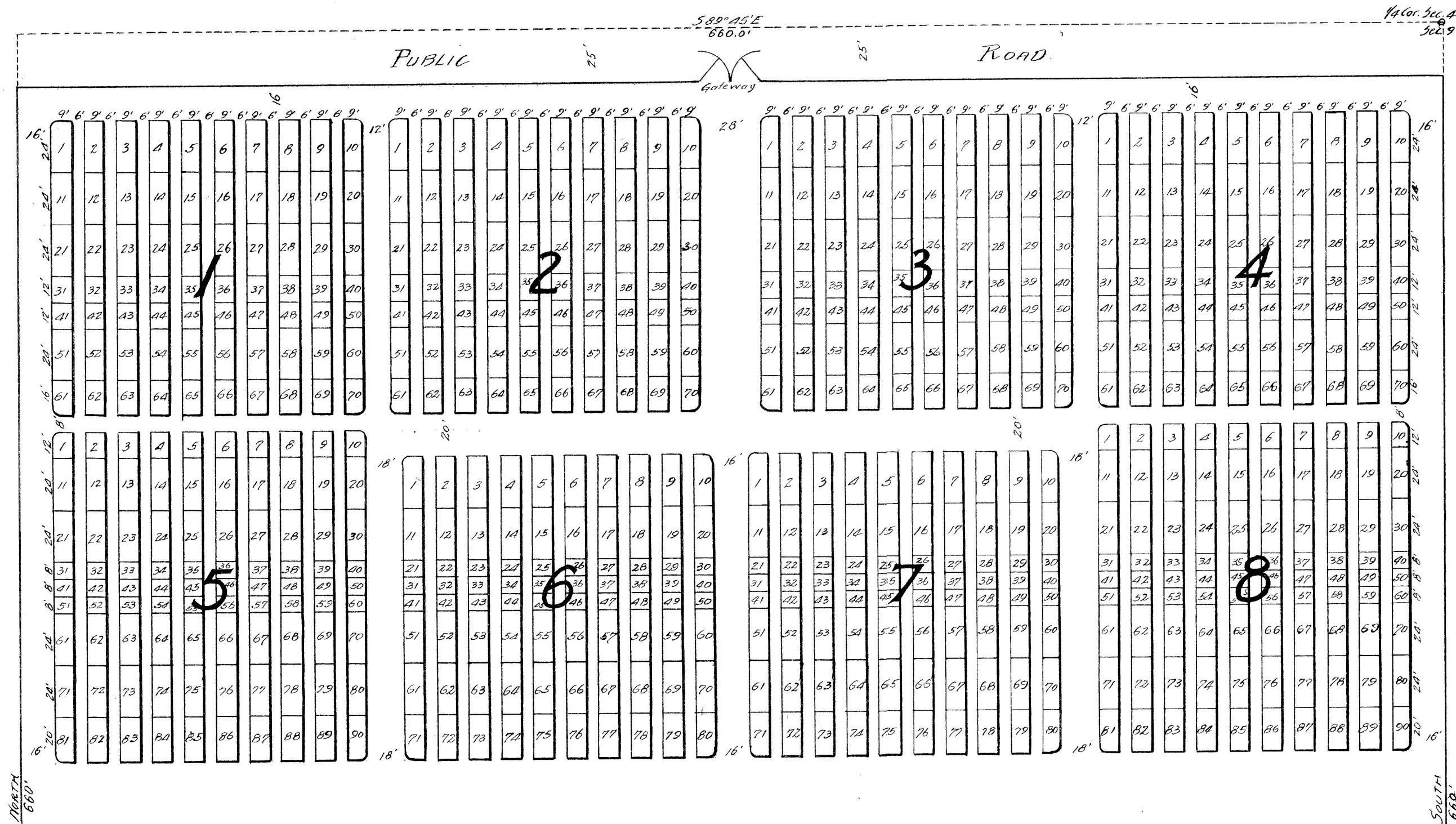


FILED ODDFELLOWS CEMETARY
