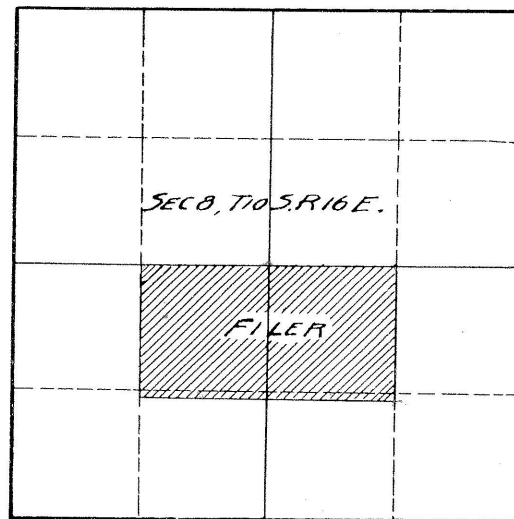
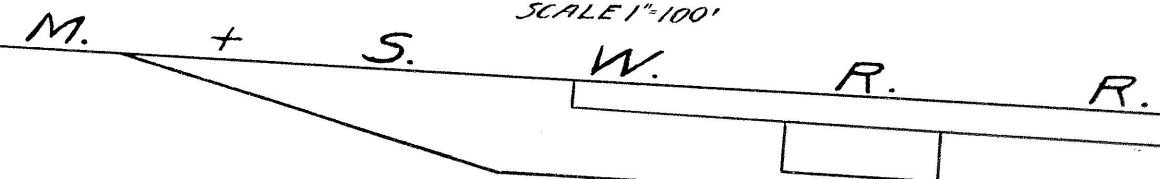




AMENDED PLAT

KNOW ALL MEN BY THESE PRESENTS, that the Filer Townsite Company, a corporation organized and existing under the laws of the State of Idaho, by its Secretary E.H. Rettig, does hereby certify that the following is a correct description of the land included in the plat of Filer which is hereto attached, said lands being known and described as being a part of Section 8, T. 5 N. R. 16 E. AM. beginning at the NW corner of the NE 1/4 of said section 8, thence easterly along North line thereof to center of said section 8, thence along the North line of the NW 1/4 of said section 8 to the NE corner of NW 1/4 of said section 8, thence southerly 1400 ft. along East line of said quarter to a point on line between the SE 1/4 and SW 1/4 of said section, thence westerly parallel with the North line of townsite as described above, to intersection with the line between the SE 1/4 and SW 1/4 of said section, a distance of 1400 ft. southerly from the NW corner, NE 1/4 of said section 8, thence northerly 1400 ft. along the West line of NE 1/4 of said section to the place of beginning.

And said corporation does further state that it is its intention to include the same and the whole thereof in the said plat of Filer. And it does further hereby declare that in consideration of the filing of said plat by the County Recorder of Cassia County, Idaho, and the acceptance by the public of the streets and alleys shown upon said plat, it does hereby give and grant to the public forever in fee simple such portions of the premises, platted as are, on said plat set apart for streets, alleys and public places for public use forever.
