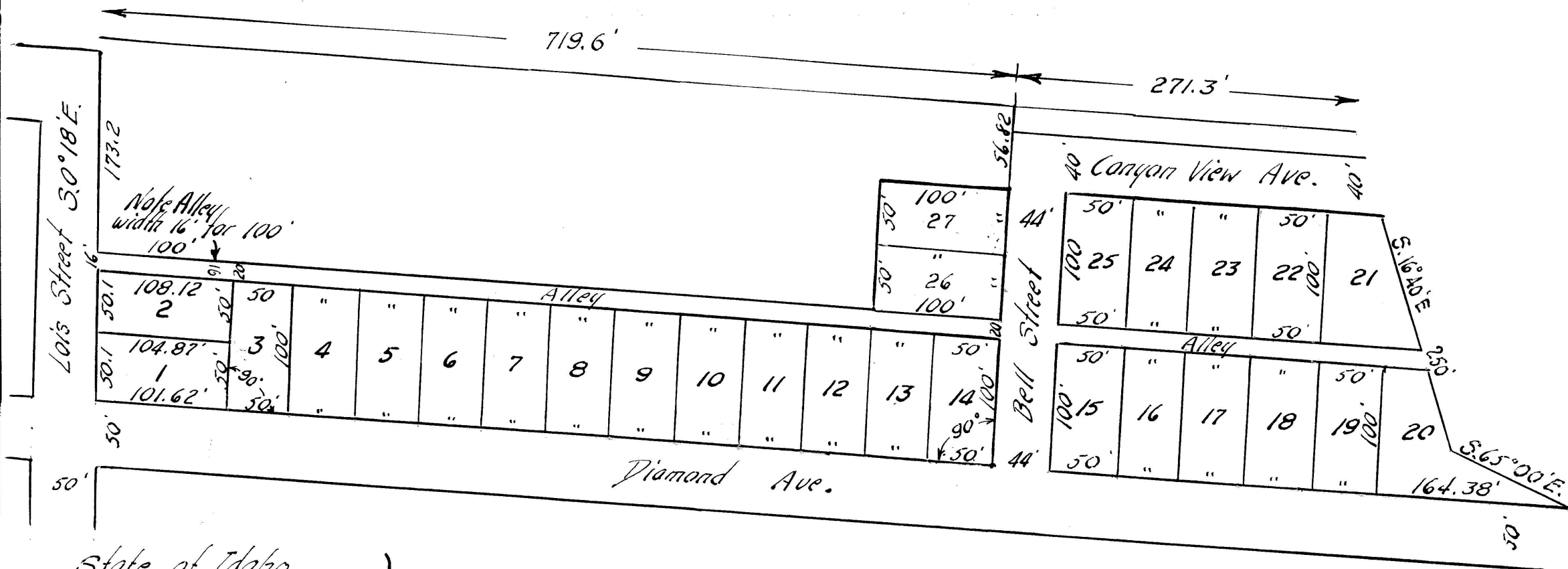


PLAT OF GARDNER SUBDIVISION TWIN FALLS - - - IDAHO

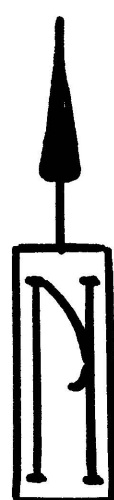
