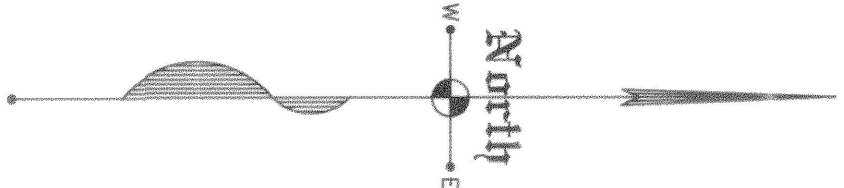
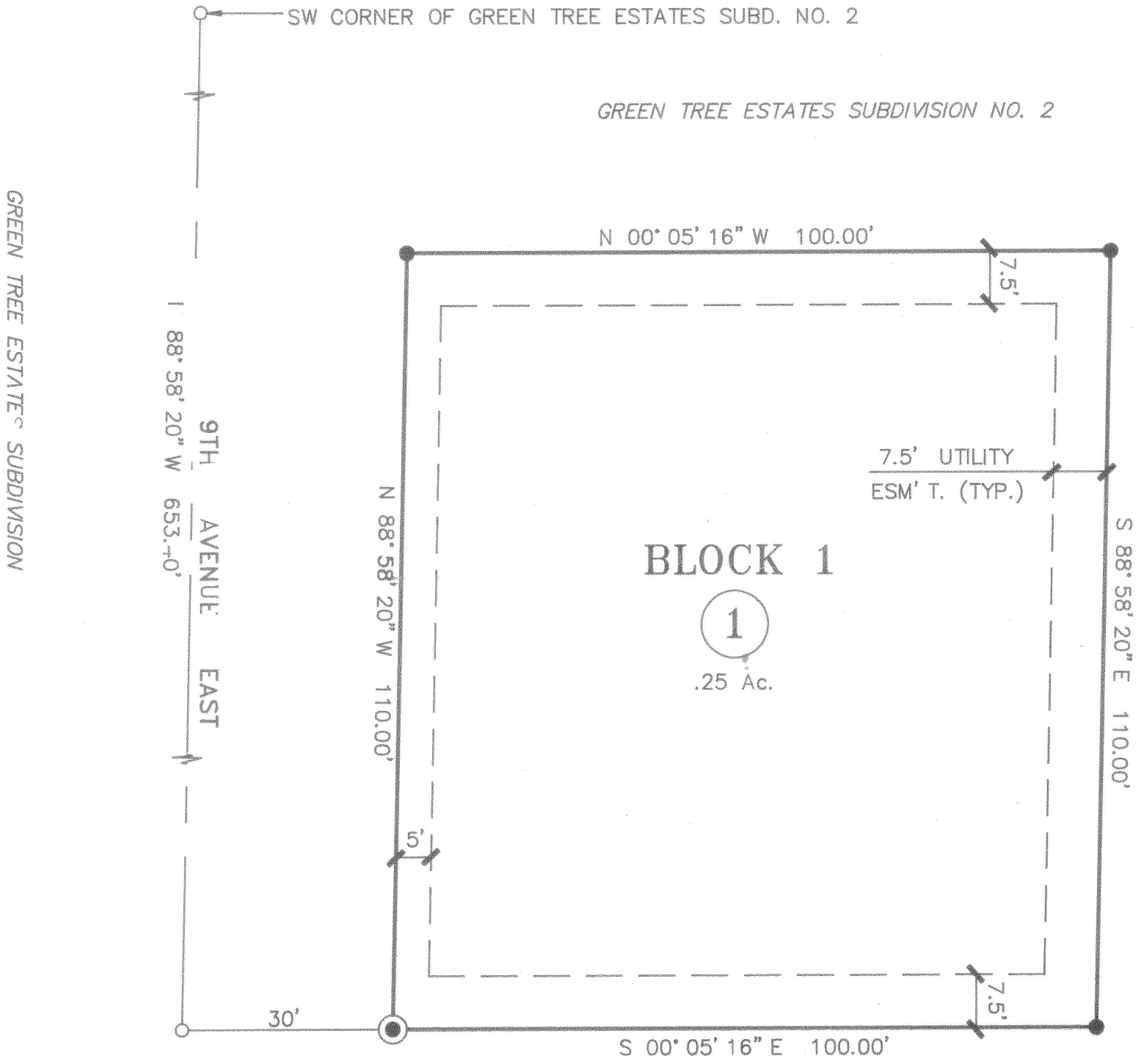


AMENDED LOT 1, BLOCK 1

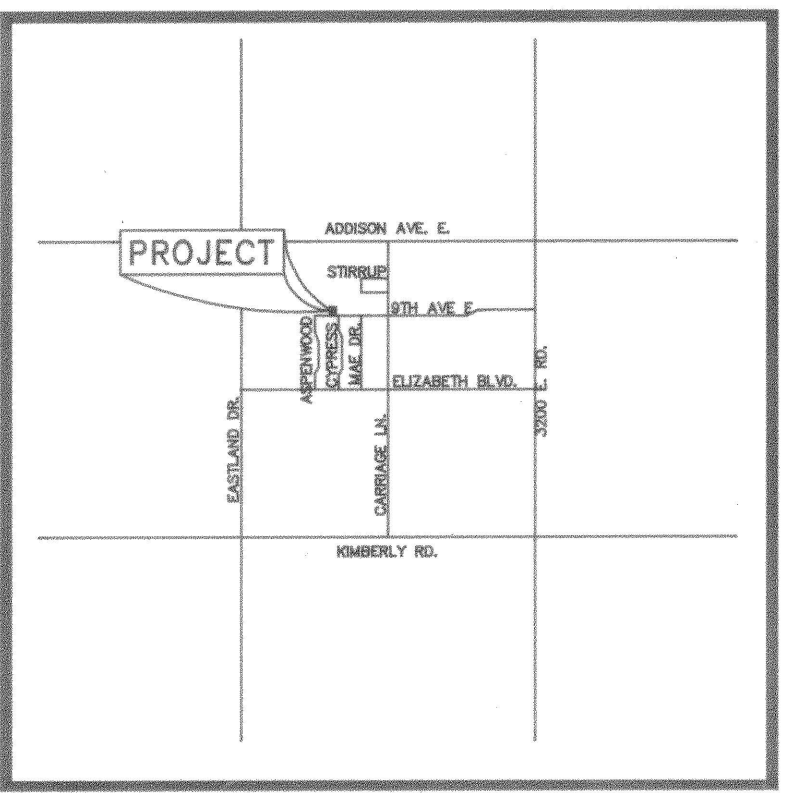
