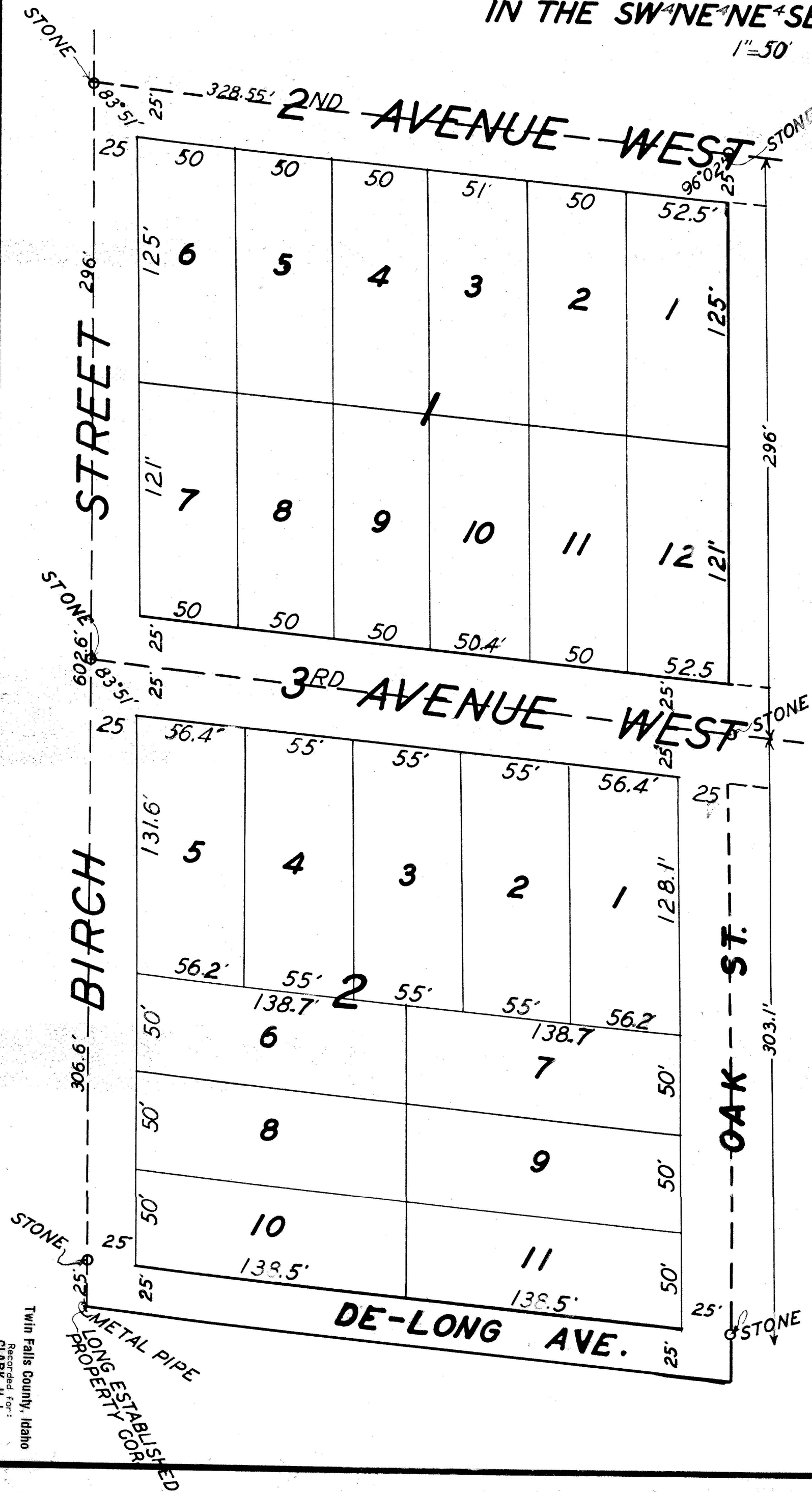


HAD CLARK SUBDIVISION
