AMENDED DEDICATION CERTIFICATE

WHEREAS, The certificate of dedication attached to the plat of Hardin Orchard Lands Subdivision No. 2, filed in the office of the County Recorder of the County of Twin Falls, State of Idaho, on the tenth day of December, 1912, and recorded in Book Three of Plats at Page Twelve, is deficient in that the notarial acknowledgment thereof is irregular, and in that there is of record no authority for the person acting as agent in the execution of the said certificate.

NOW THEREFORE, This instrument, executed for correction of the said certificate and as an amendment thereof, that the following is a correct description of the land included in the said plat, said land being situated in the County of Twin Falls, State of Idaho, and described as follows: to-wit: the West half of the Northeast quarter of Section thirty two, Township ten, South, Range seventeen, East, Boise Meridian, and that it is their intention to include the same and the whole thereof in the said plat; And the said parties, in consideration of the acceptance of the same by the public, do hereby give and grant to the public forever, in fee simple, such portions of the premises plotted in the said plat as are thereon set apart for public roads.

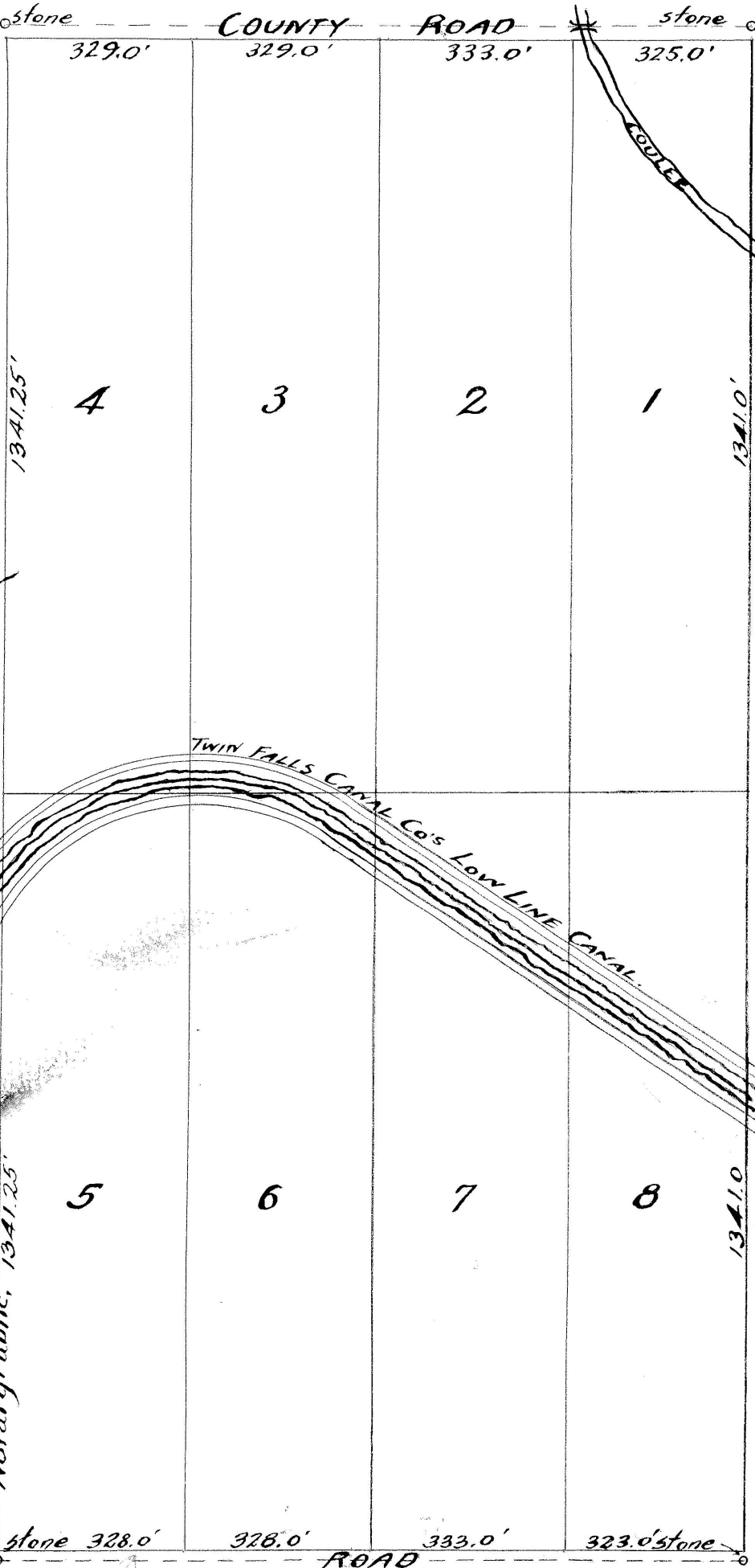
