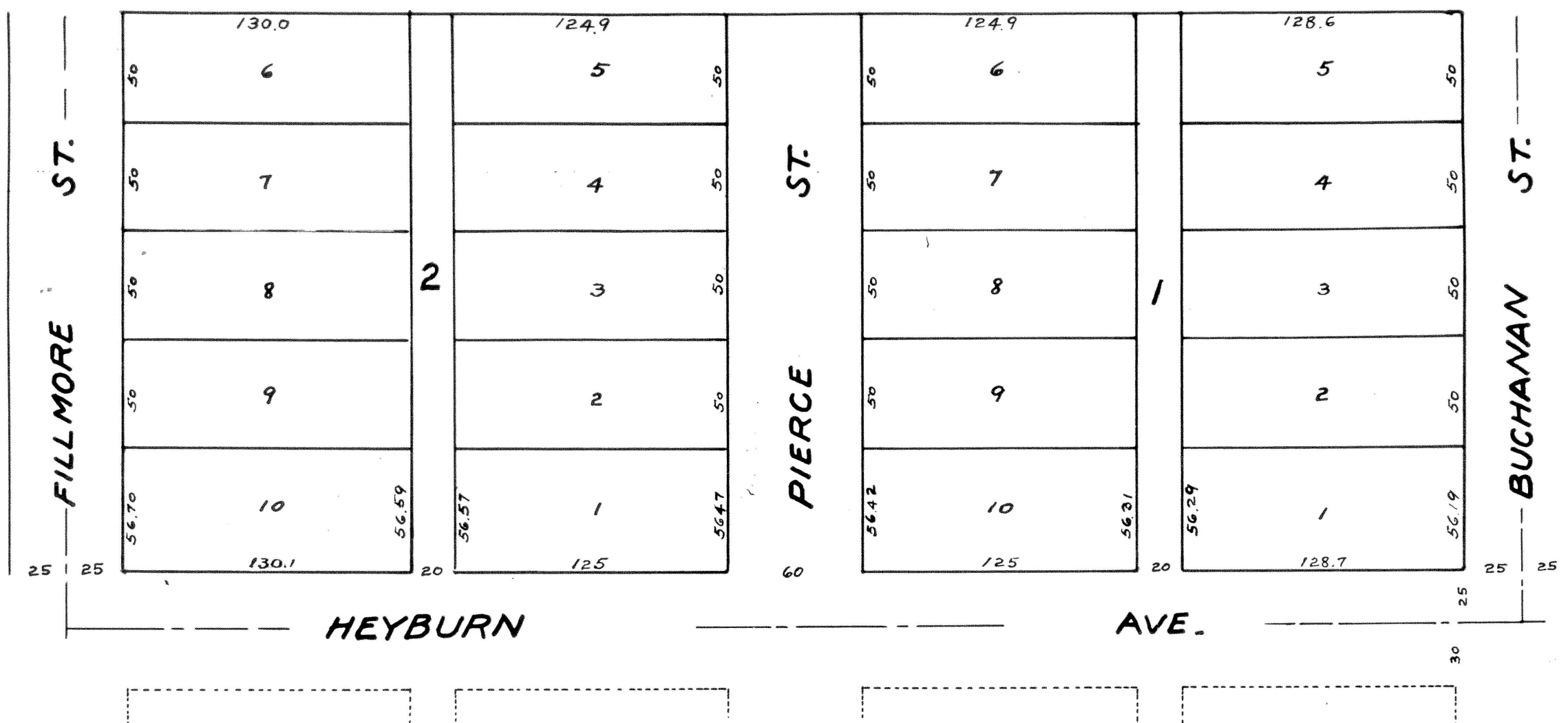


**PLAT OF
