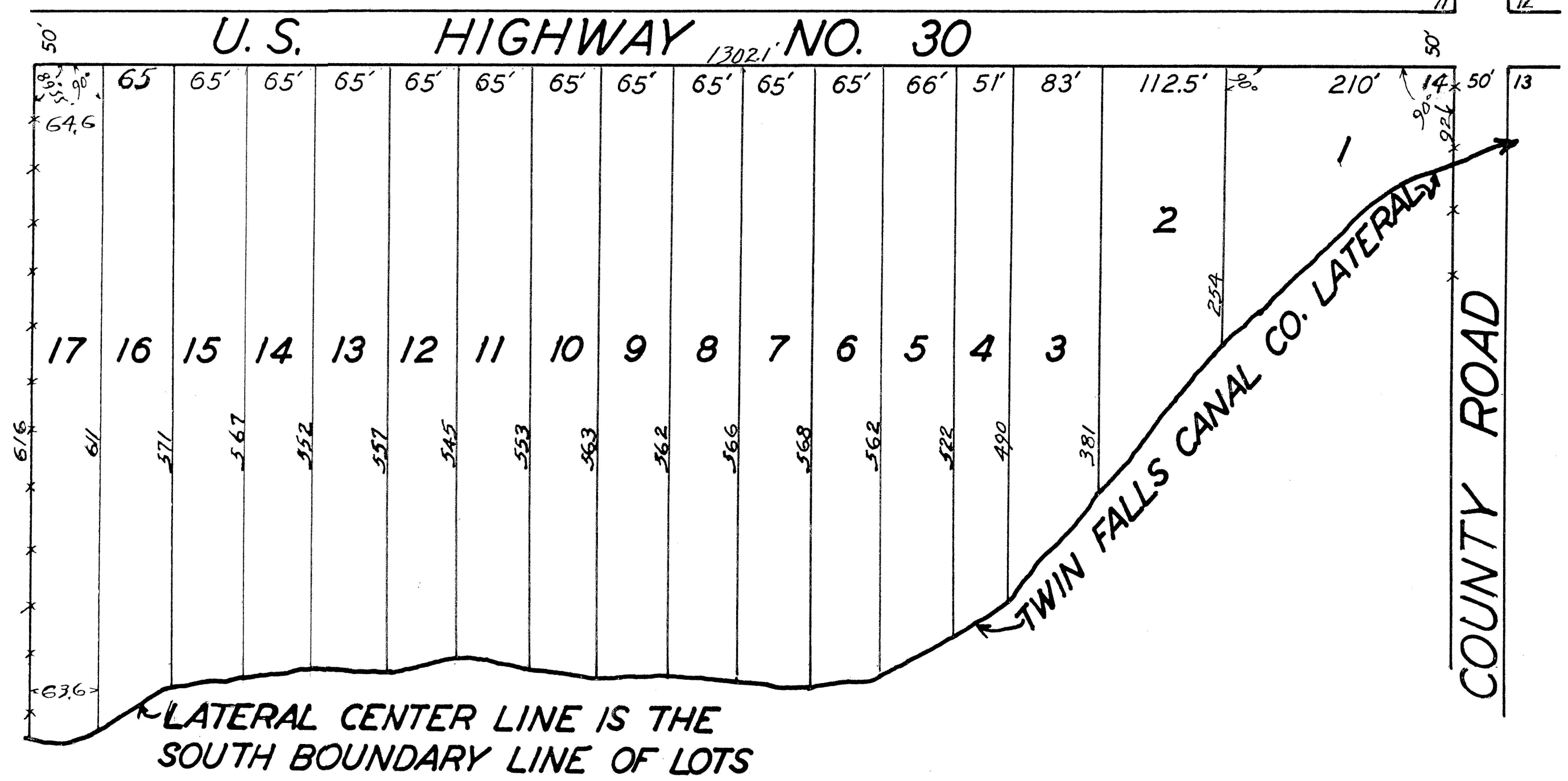




DEDICATION
