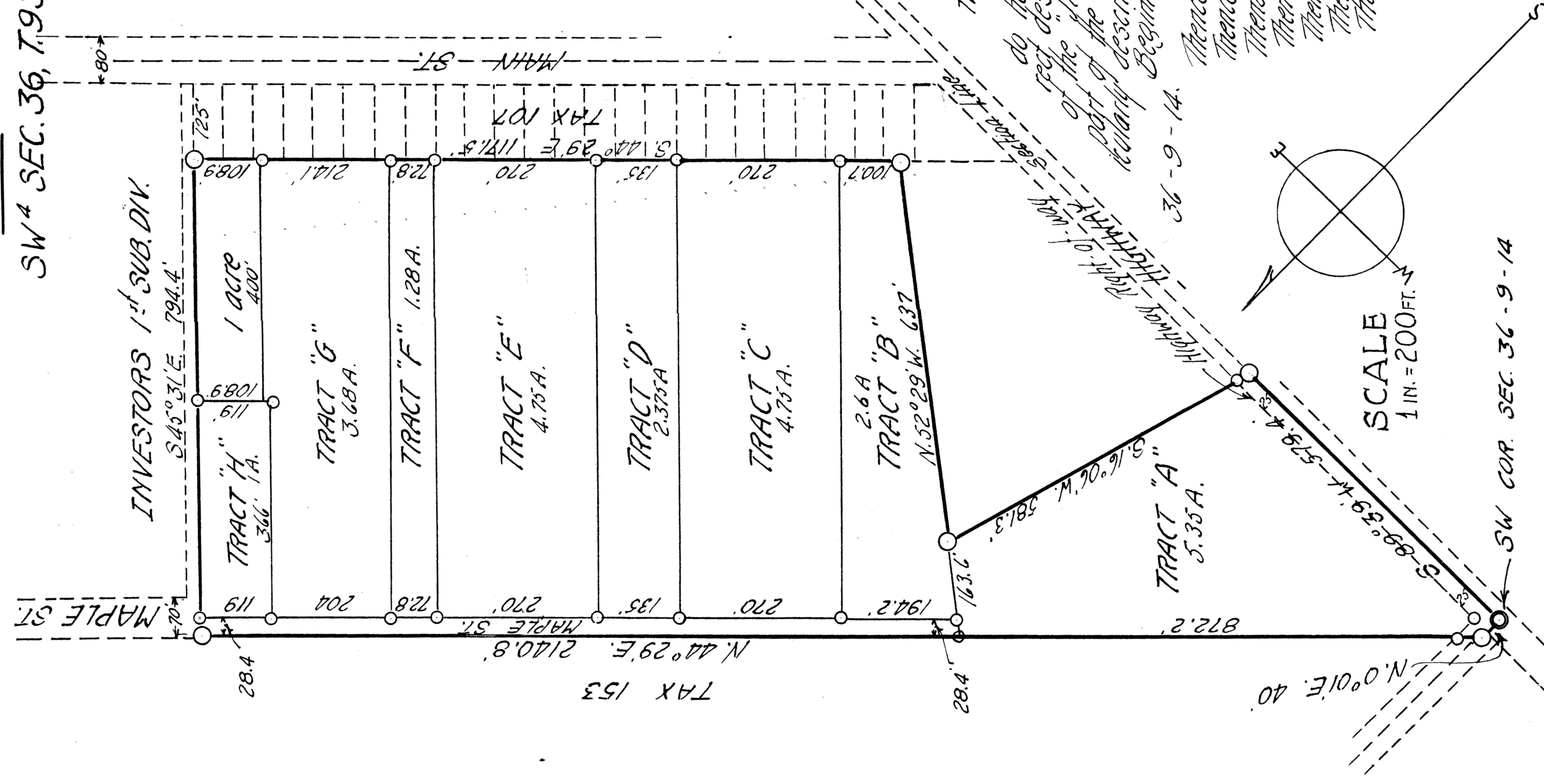


# MAP OF Jacobsen Tracts AT BUHL - IDAHO
