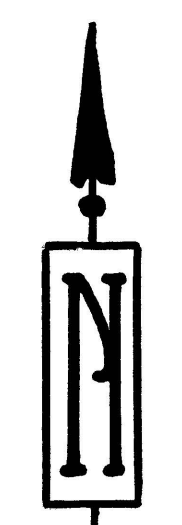
PLAT OF

ADDITION - TWIN FALLS

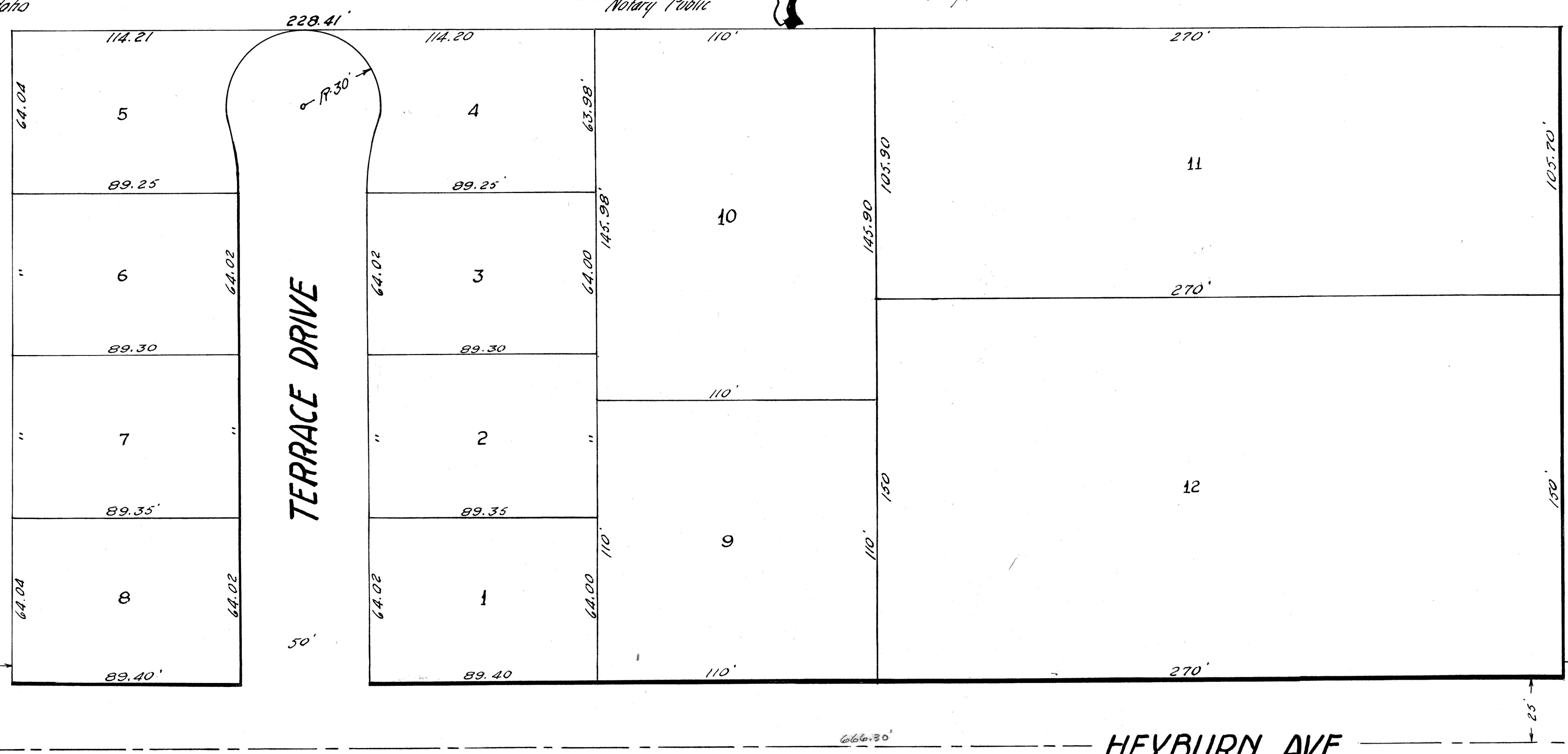
BUCHANAN ST.
