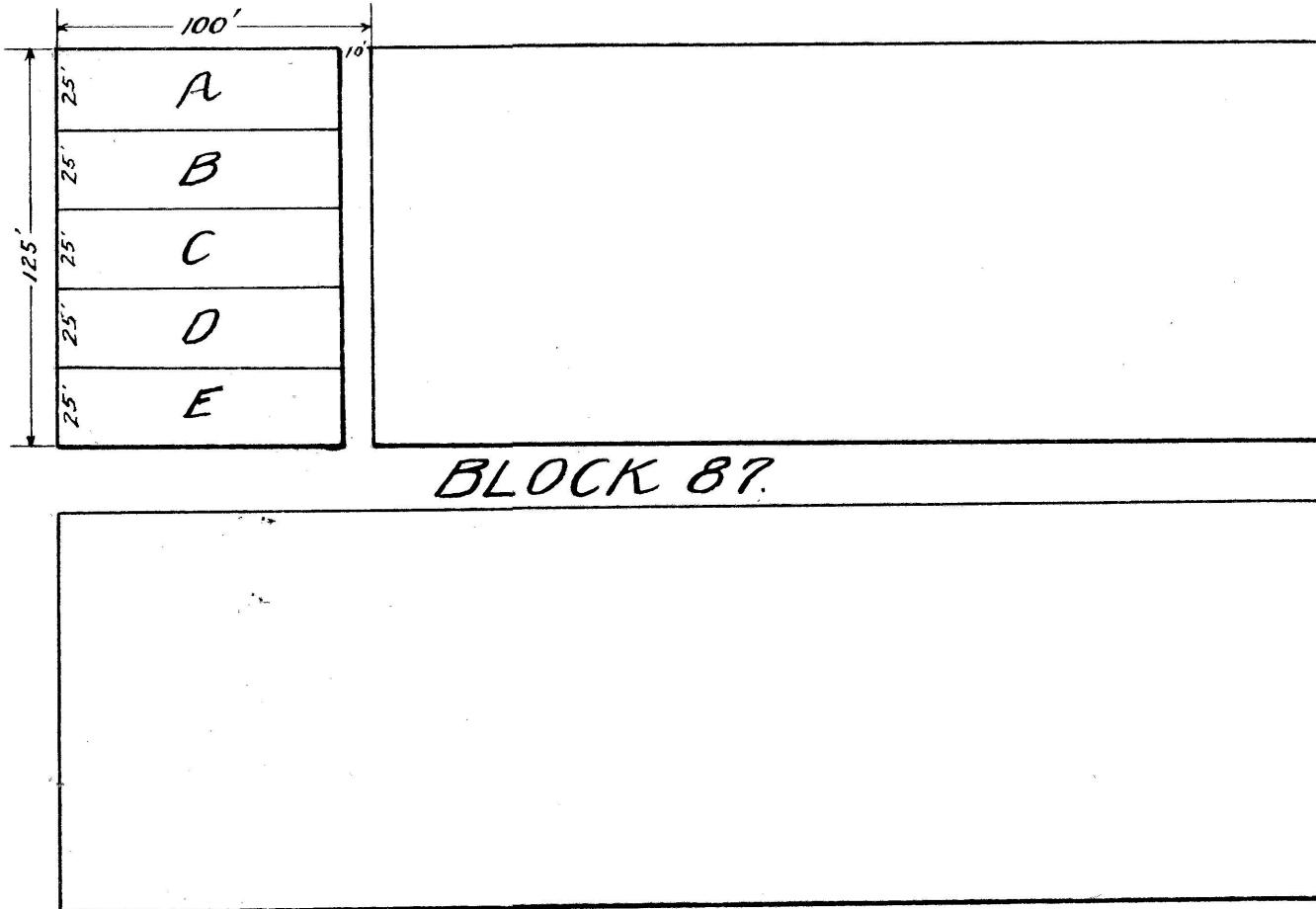

KNOW ALL MEN BY THESE PRESENTS: That I the undersigned do hereby certify that the following is a true and correct description of the land included in Maxwell's Subdivision of Block 87 in Twin Falls, Idaho, which is included herewith, said land being shown and described as follows: Beginning at the corner of Shoshone St. and 2nd Ave. East, thence 100' southeasterly to lot corner between Lots 4 and 5 of said Block 87 of original survey; thence southeasterly 125' to alley; thence along alley 100ft. to Shoshone St.; thence 125ft. along Shoshone St. to point of beginning. And I do further certify that it is my intention to include the same in the said plat thereof and that in consideration of the filing of said plat by the County Recorder of Twin Falls County, Idaho, and the acceptance by the public of the alley shown on said plat do hereby give and grant to the public forever in fee simple, such portion of said premises plotted as are on the said plat set aside for an alley for public use forever.
