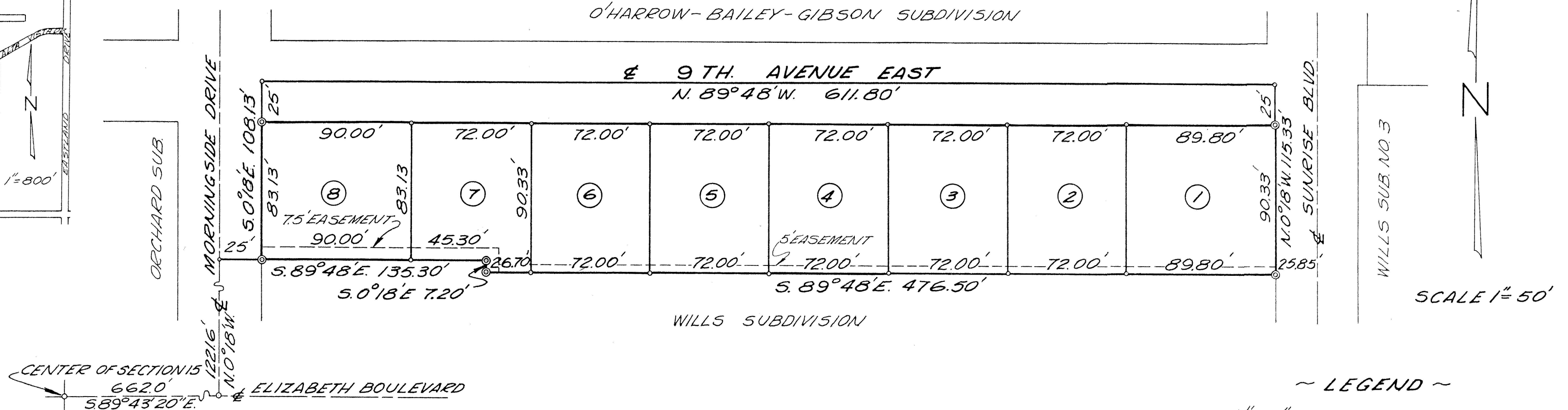
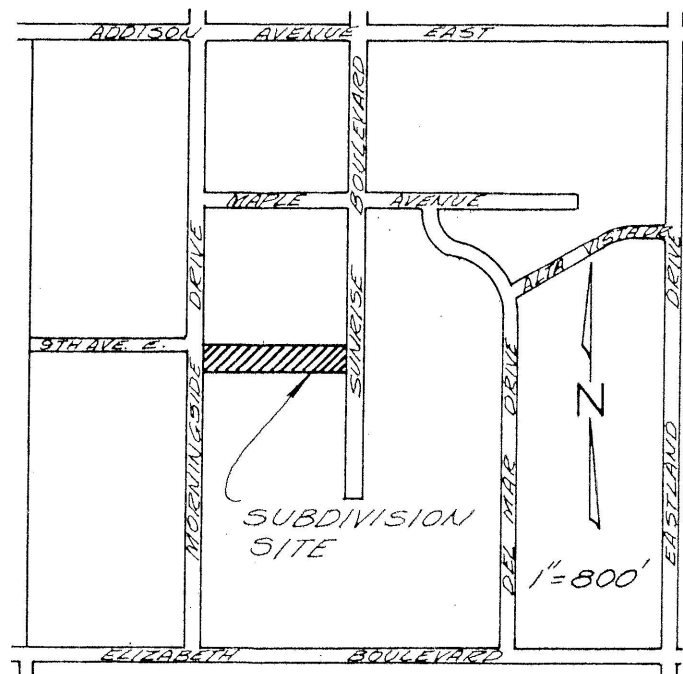

CERTIFICATE OF OWNERS

This is to certify that we the undersigned are the owners in fee simple of the following described property: The North 1/3 of lot 8, Hill Tract No. 2 & lot 12, Wills Subdivision in the SW 1/4, NE 1/4, Section 15, T.10S., R.17E., B.M., Twin Falls, Idaho; more particularly described as follows: From the center of Section 15 a distance of 662.0 feet on a bearing of 5.89° 43' 20" E, then 122.6 feet on a bearing of N. 0° 18' W, then 25.0 feet on a bearing of 5.89° 48' E to the point of beginning; From this point of beginning, a distance of 135.30 feet on a bearing of 5.89° 48' E; then 7.20 feet on a bearing of S. 0° 18' E; then 476.50 feet on a bearing of S. 89° 48' E; then 115.33 feet on a bearing of N. 0° 18' W; then 611.80 feet on a bearing of N. 89° 48' W; then 108.13 feet on a bearing of 5.0° 18' E to the point of beginning, containing 1.6 acres more or less. That it is the intention of the undersigned to and they do hereby include said land in this plat, that the undersigned does by these presents dedicate to the public for public use forever, all streets as shown on this plat; the easements indicated on this plat are not dedicated to the public, but the right to use said easements is hereby perpetually reserved for public utilities and for such other uses as designated hereon, and no structures other than for such utility purposes are to be erected within the lines of said easements.

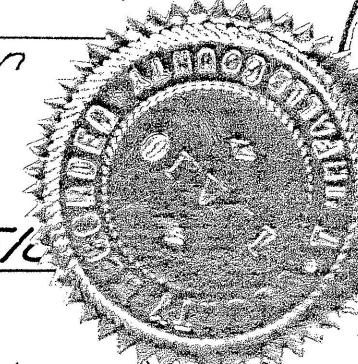
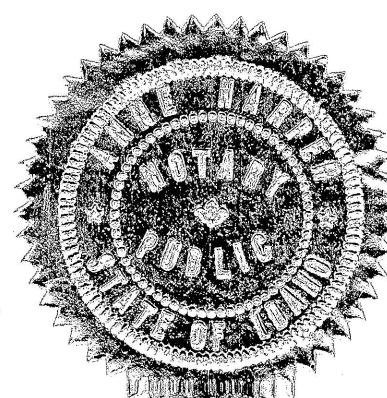
