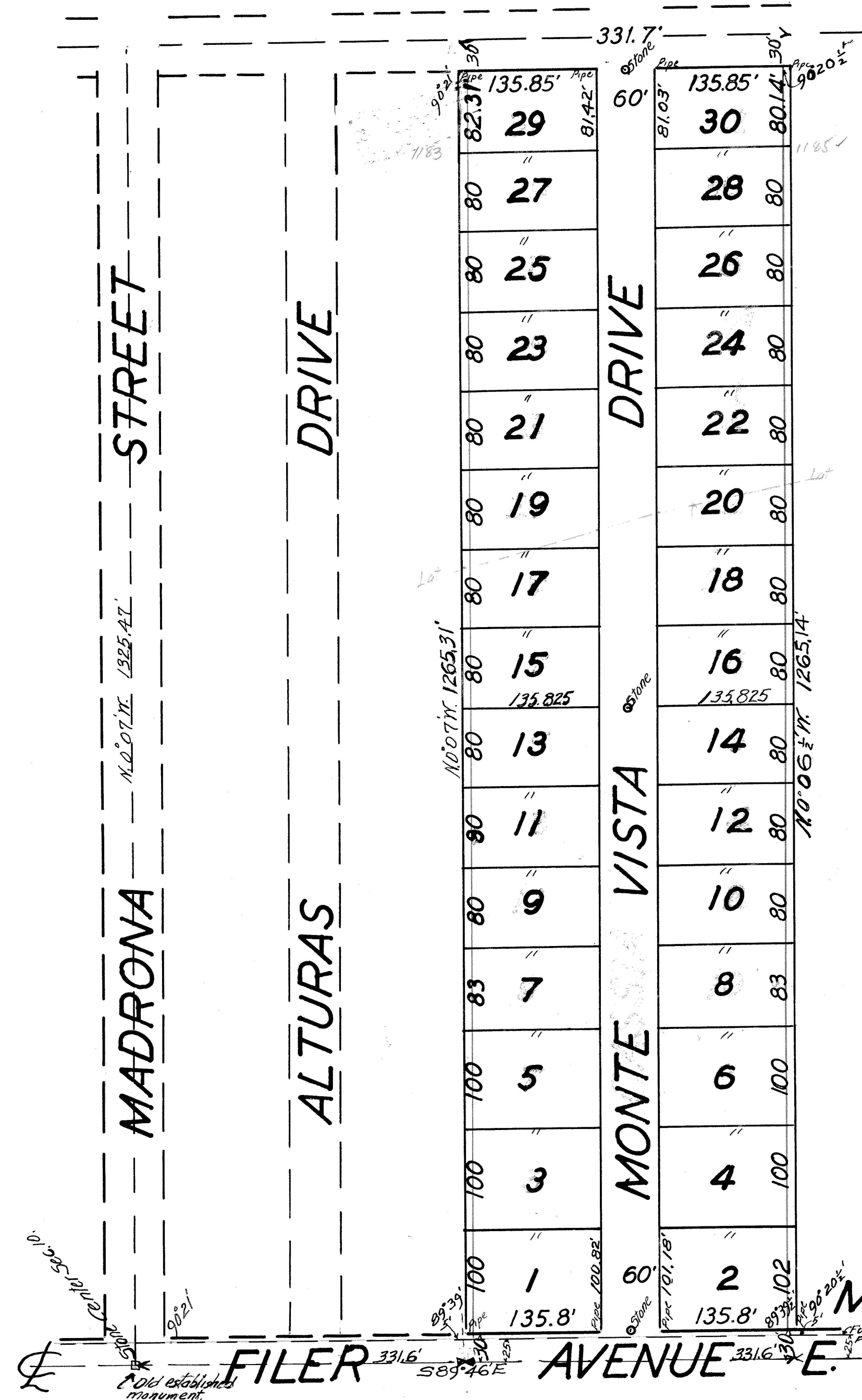




DEDICATION
