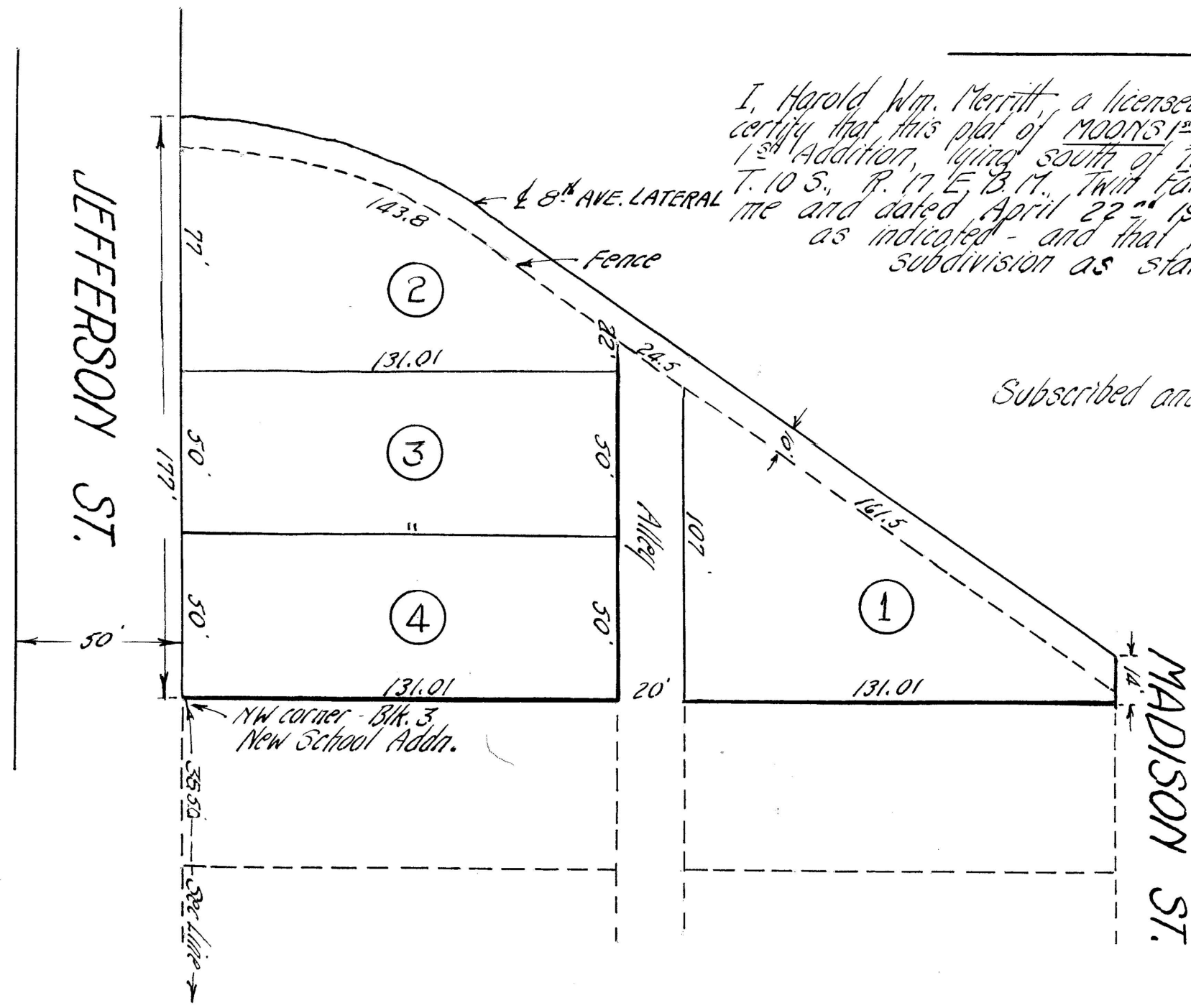
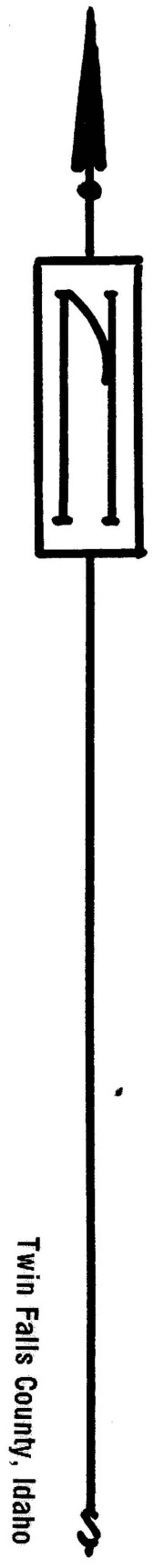
That we
