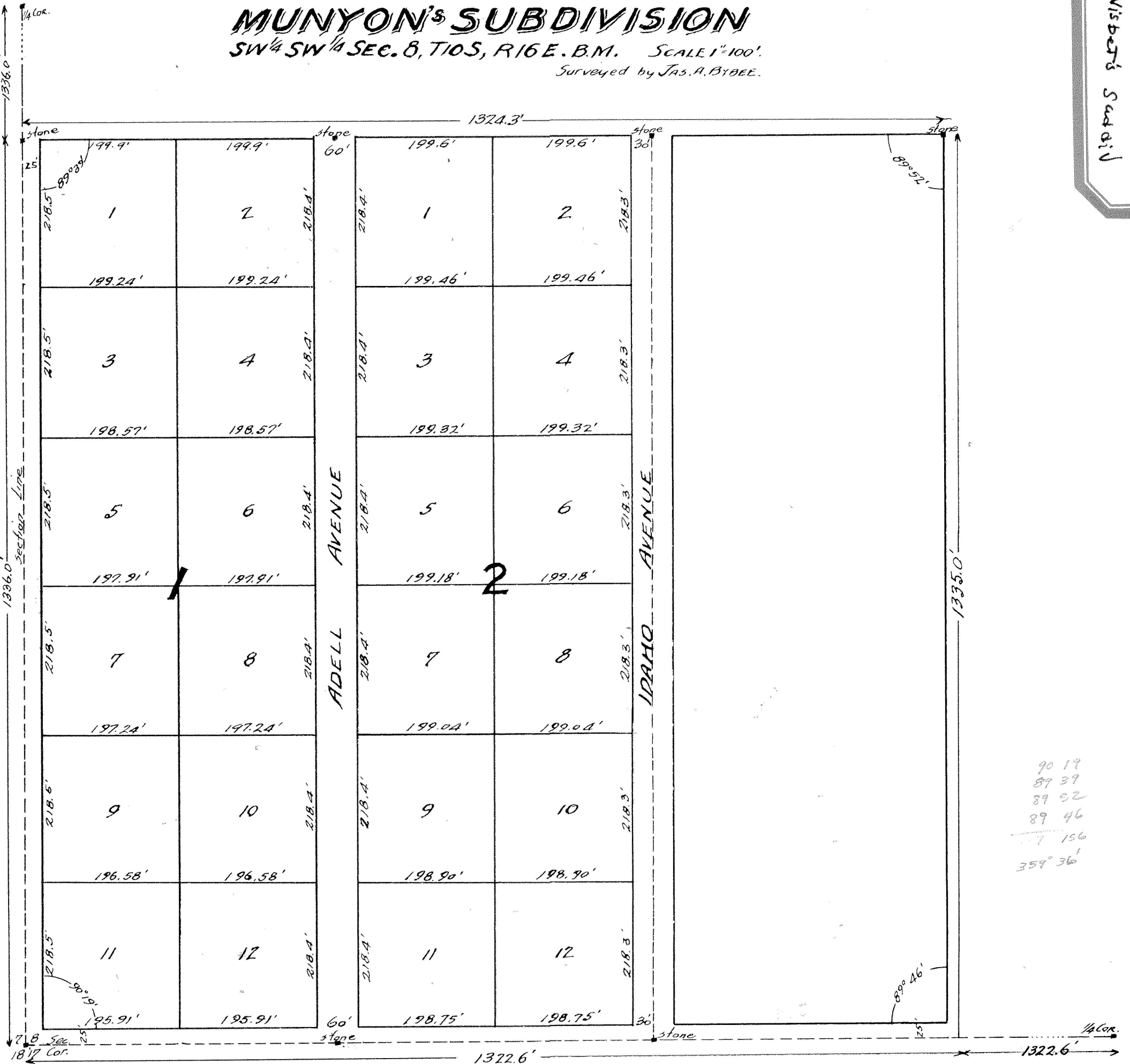


FINAL AND AMENDED PLAT OF
