CERTIFICATION:

I, Harold Wm. Merritt, a licensed engineer of the State of Idaho, hereby certify that this plat of the VILLAGE of MURTAUGH was prepared by me from data secured from the REVISED MAP of MURTAUGH filed Mar. 1st 1918 with the County Recorder of said County of Twin Falls and of record in Book 2, of PLATS, Page 20, and from minutes of County Commissioners meeting dated Sept. 15, 1937 and of record in Book 8 Commissioners Minutes Page 348-550, ordering the incorporation of said VILLAGE of MURTAUGH with boundaries as follows:

Beginning at a point on the south boundary line of the SW⁴ of Sec. 6, T.11S., R.20E.B.1. which is 245 ft. west of the S.E. cor. of said SW⁴ of Sec. 6, T.11S., R.20E.B.1. thence north parallel to the east line of the SW⁴ of Sec. 6-11-20 a dist. of 655 ft., thence east along the south line of tax #39 to the east line of said SW⁴ thence north along the east line of said SW⁴ to the SW cor. of tax #237, thence east to the SE cor. of tax #237, thence north to the NE cor. of tax #237, thence west along the north line of tax #237 a dist. of 46.4 ft., thence north to the NE cor. of tax #236, thence west to the center of said SW⁴ of 6-11-20, hereafter determined, thence north 330 feet along the east line of Lot 6 of said 6-11-20, thence west parallel to the south line of said Lot 6 a dist. of 555 ft. to a point on the west line of the O.S.L. R.R. right of way, thence south parallel to the east line of said Lot 6 a dist. of 182 ft., thence west parallel to the south line of said Lot 6 to the northwest cor. of tax #257, thence south 827.6 ft., parallel to the west boundary line of the original plat of Murtaugh Township, on file in Plat Book 3, Page 32, in the office of the County Recorder of Twin Falls, County, Idaho, thence east a distance of 1223 feet along the south boundary line of Murtaugh Township, thence south parallel to the east boundary of said Lot 7, thence east along the section line between Secs. 6 and 7, to the Point of Beginning.
