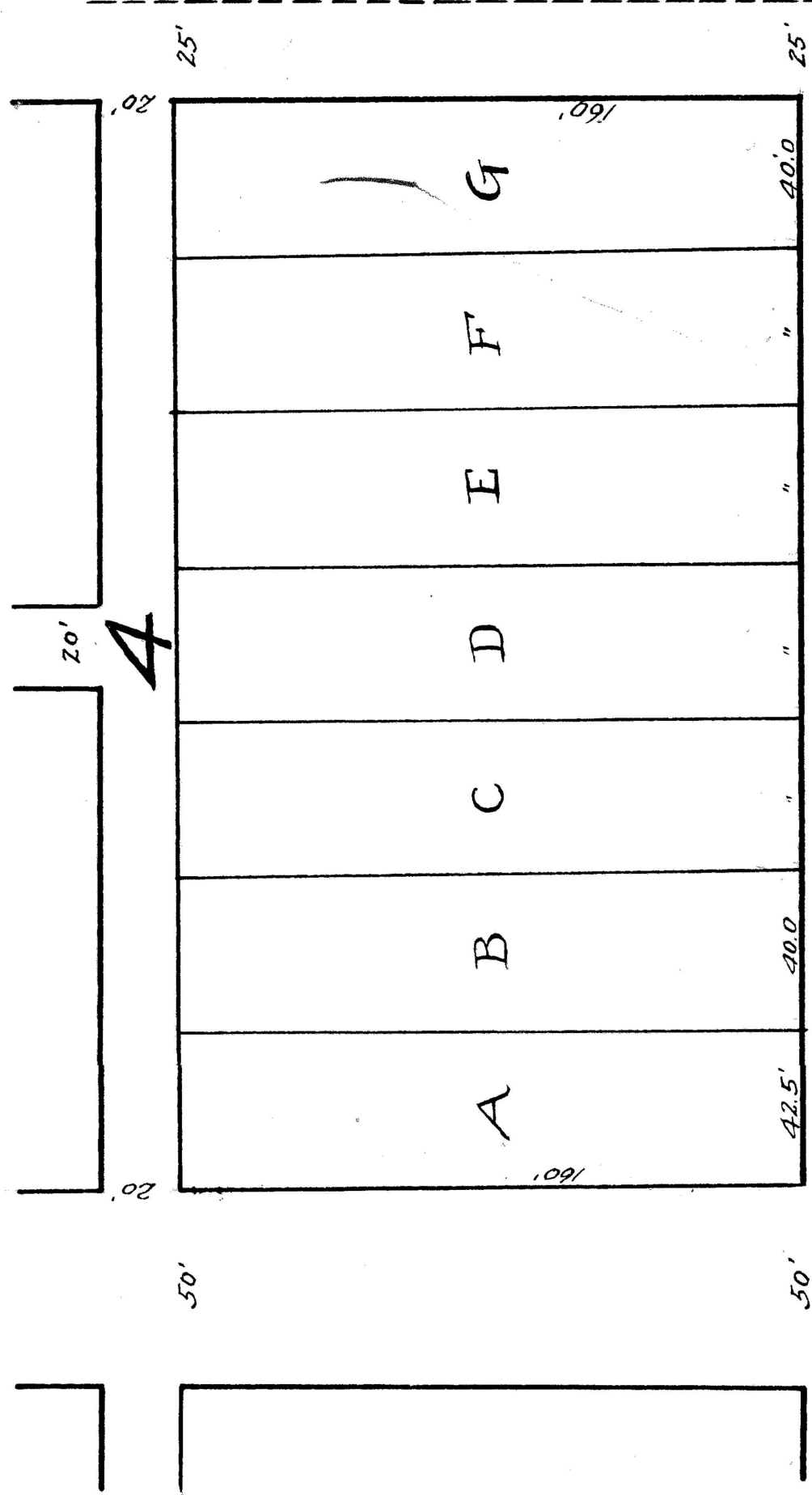


AMENDED PLAT OF LOTS 4, 5, 6, 7 & 8
