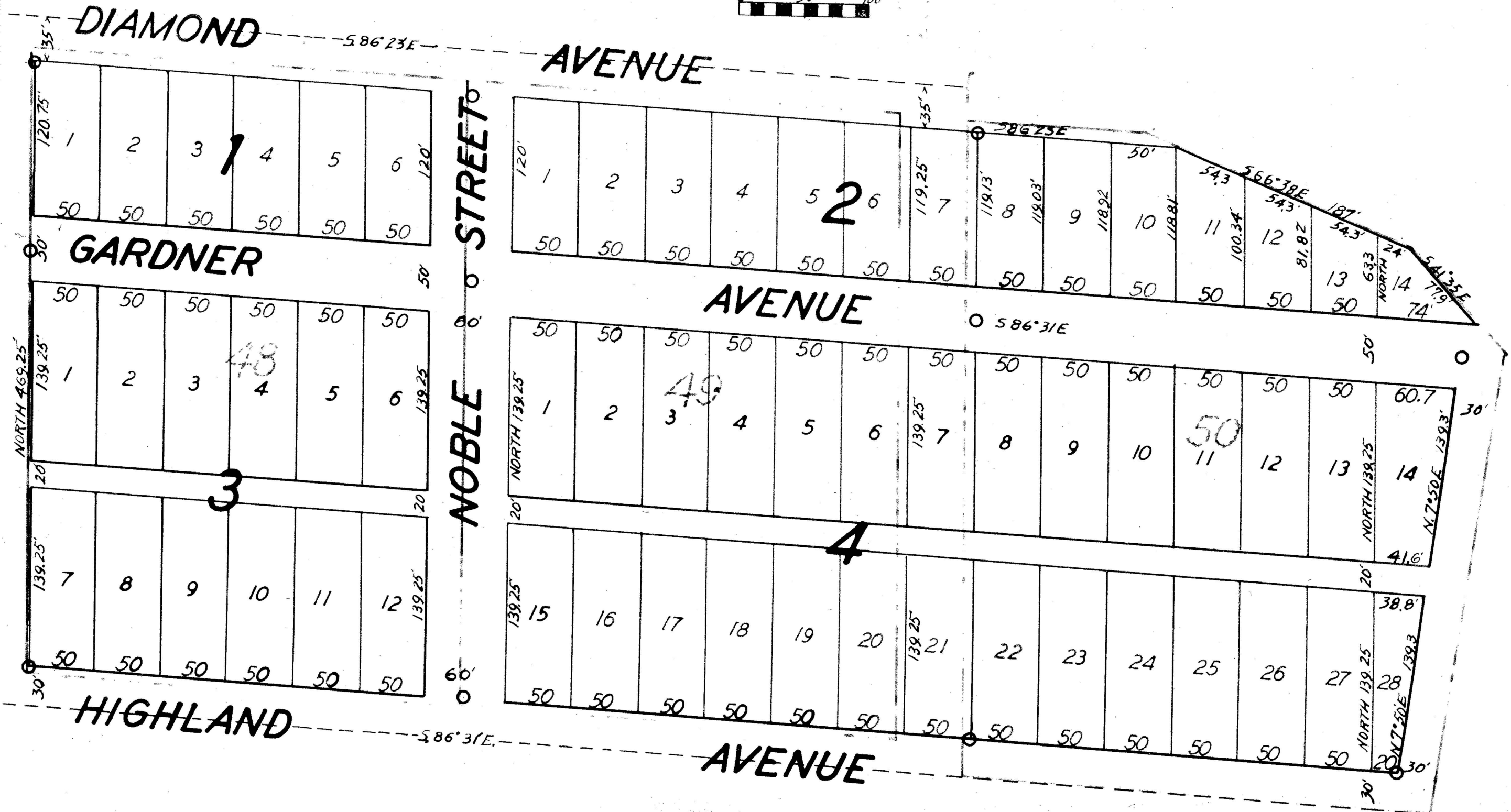
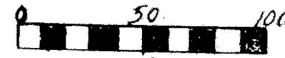


AMENDED MAP
