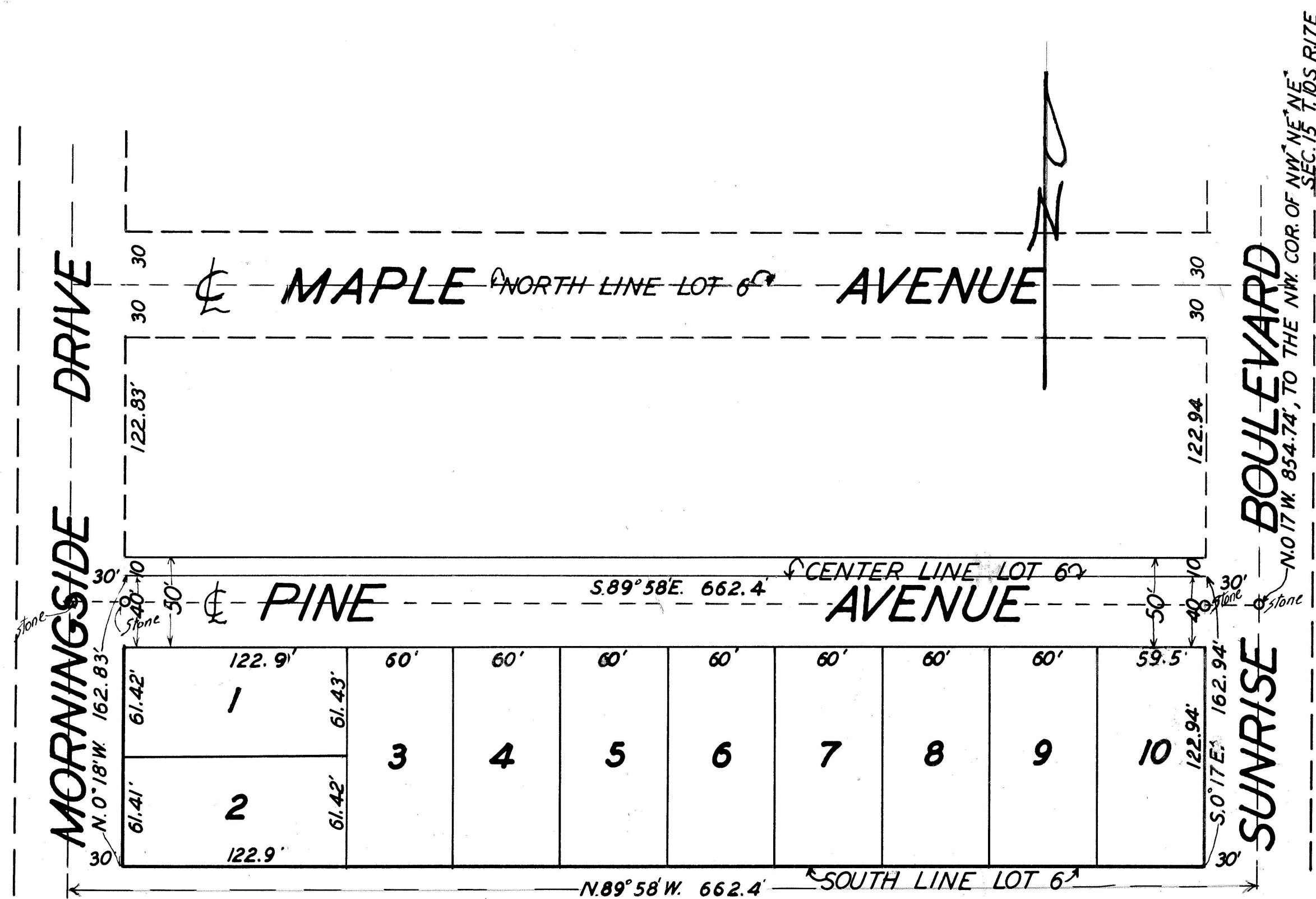
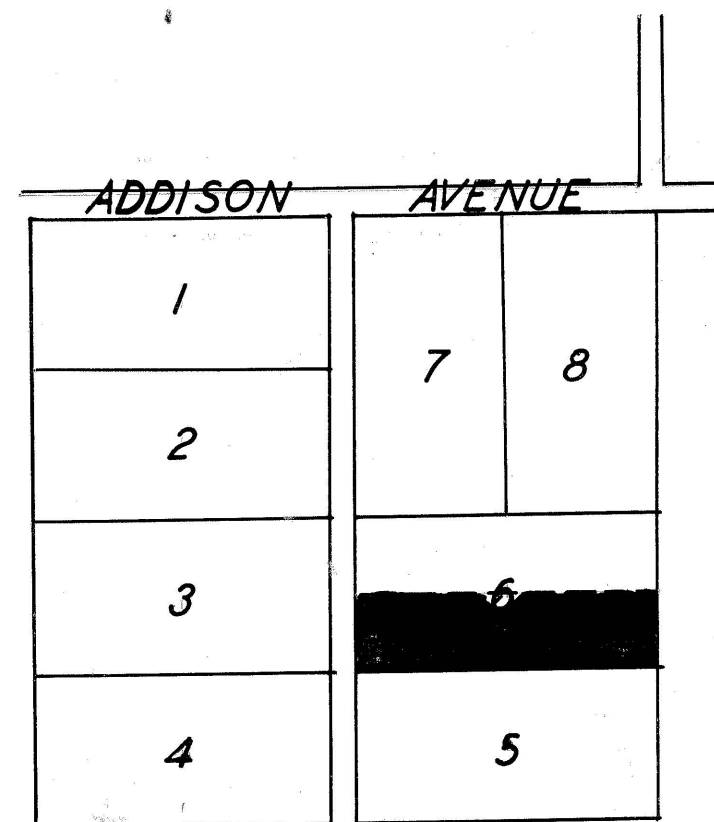




Note: Block and lot corners are steel rods.
