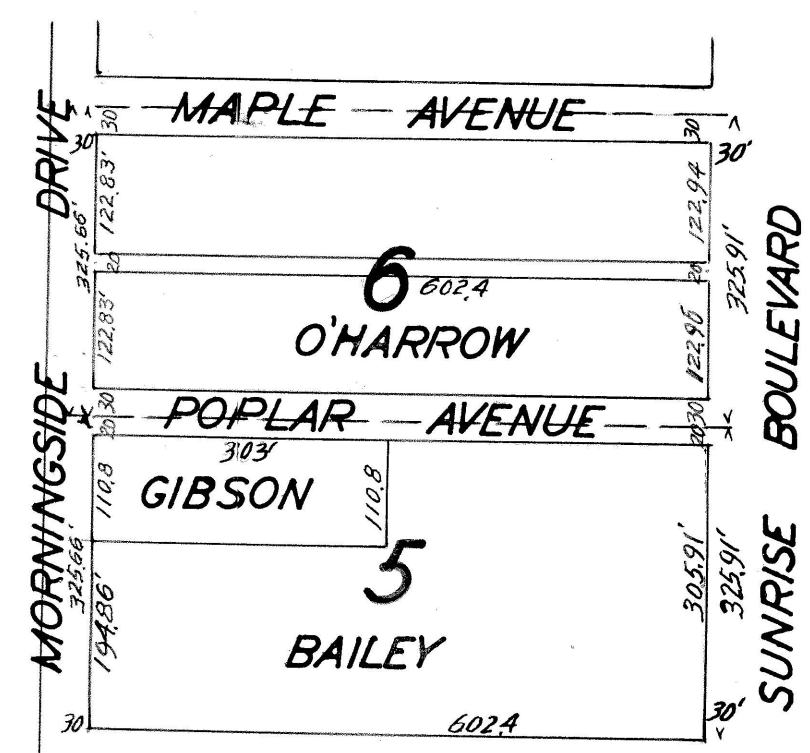
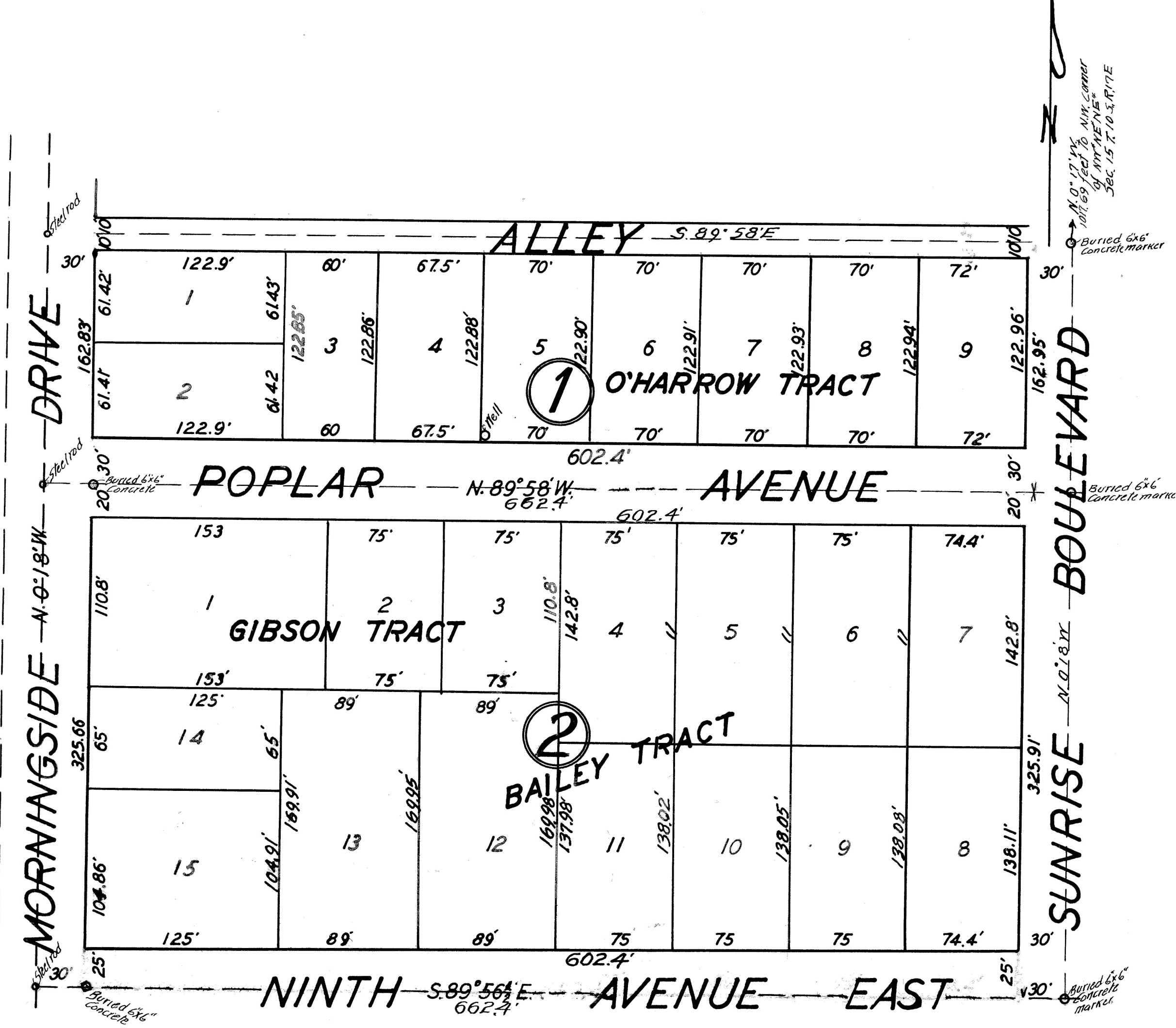
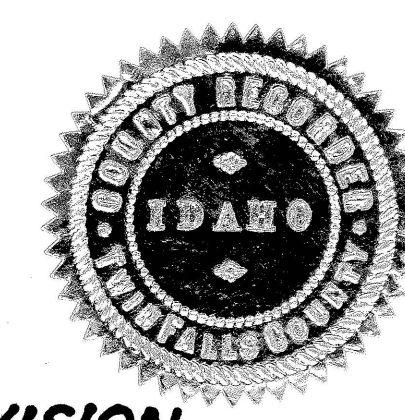




INDEX MAP
