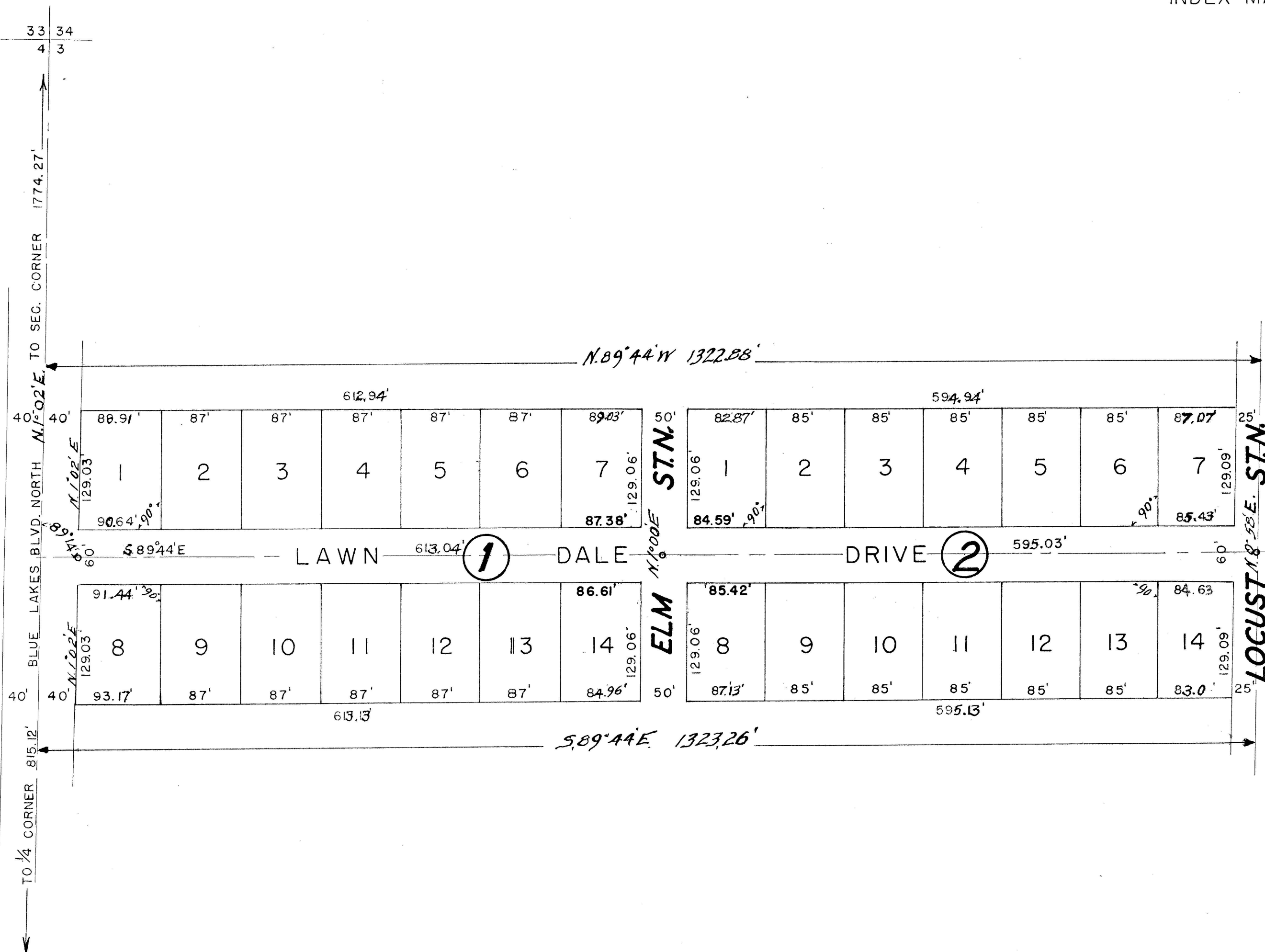


INDEX MAP
