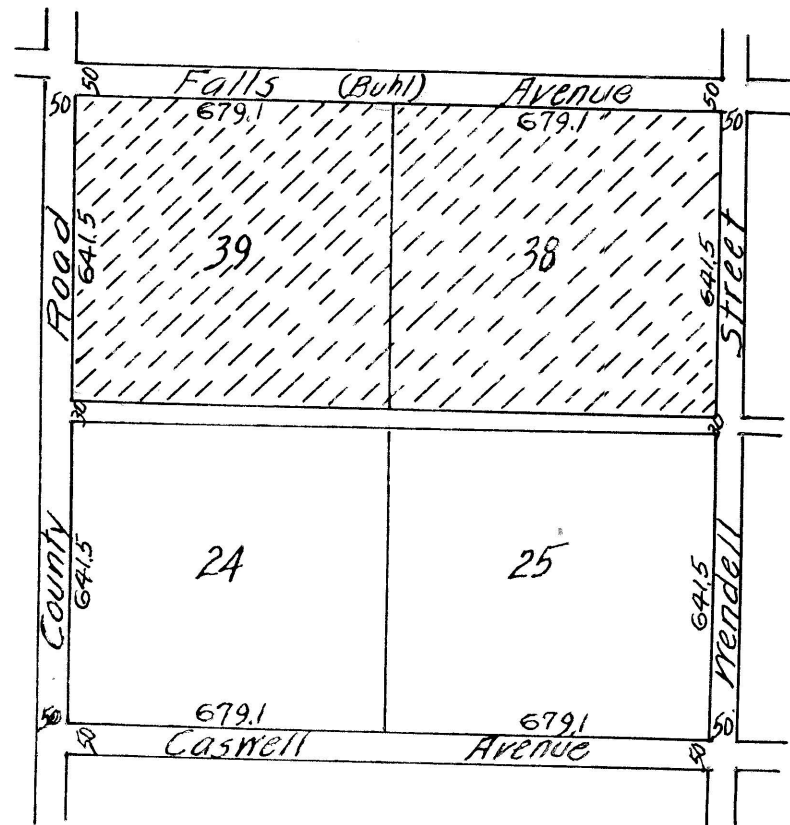
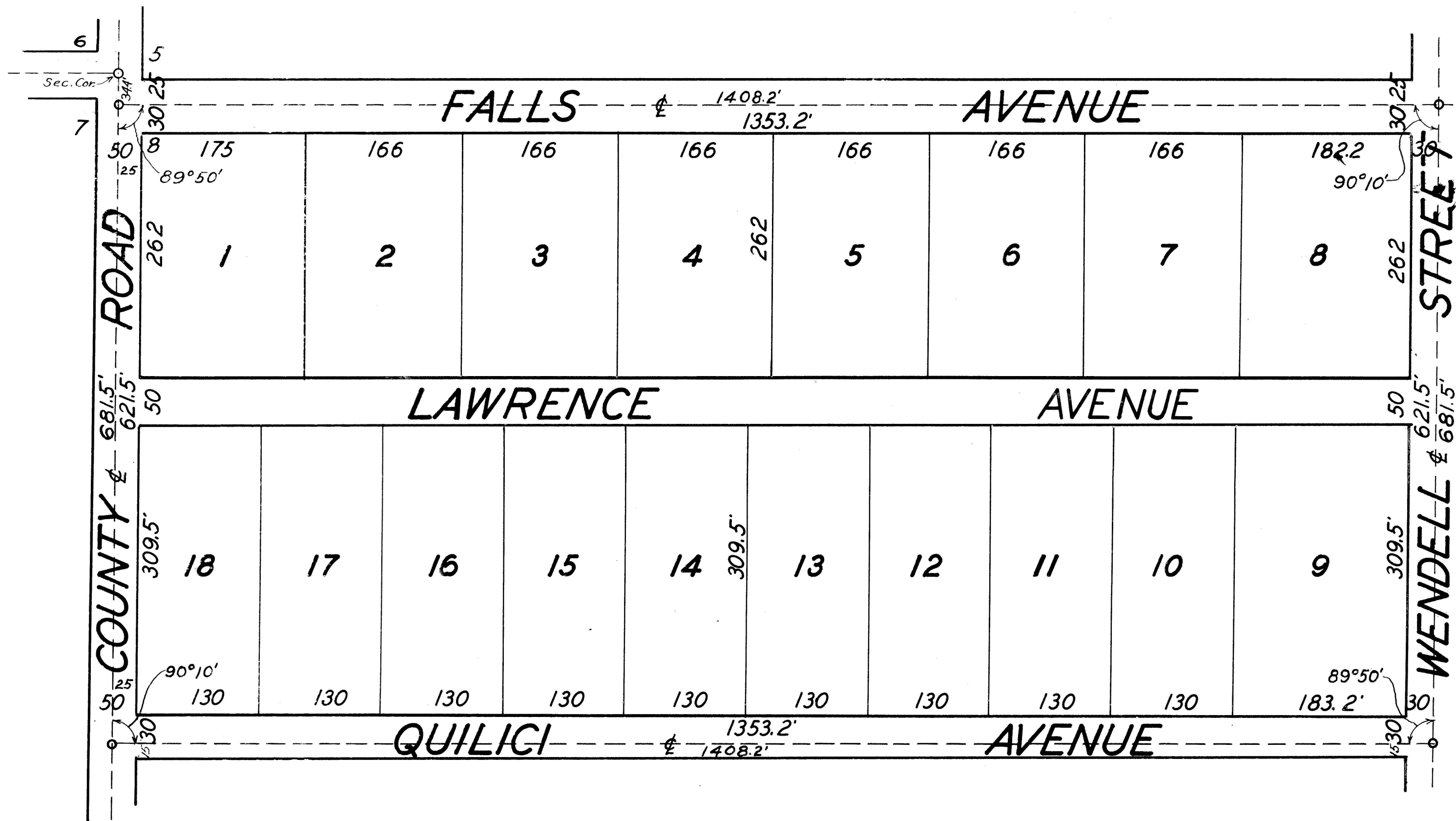




INDEX MAP
