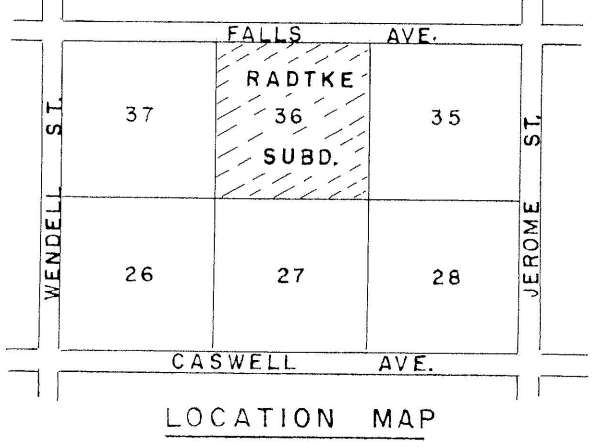
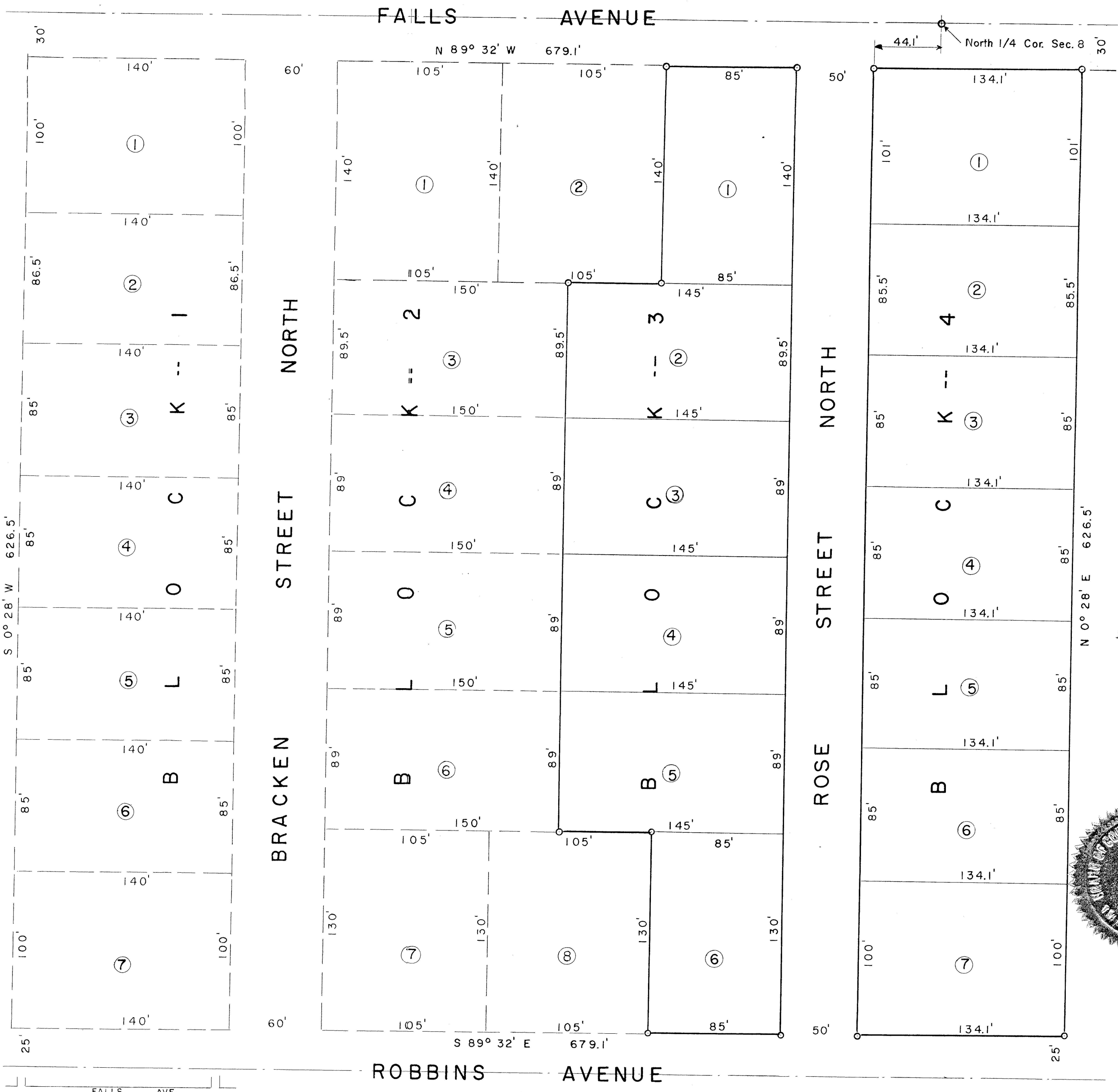




DEDICATION

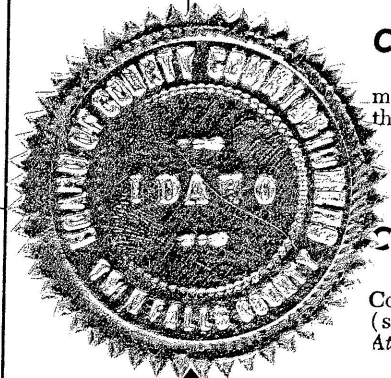
