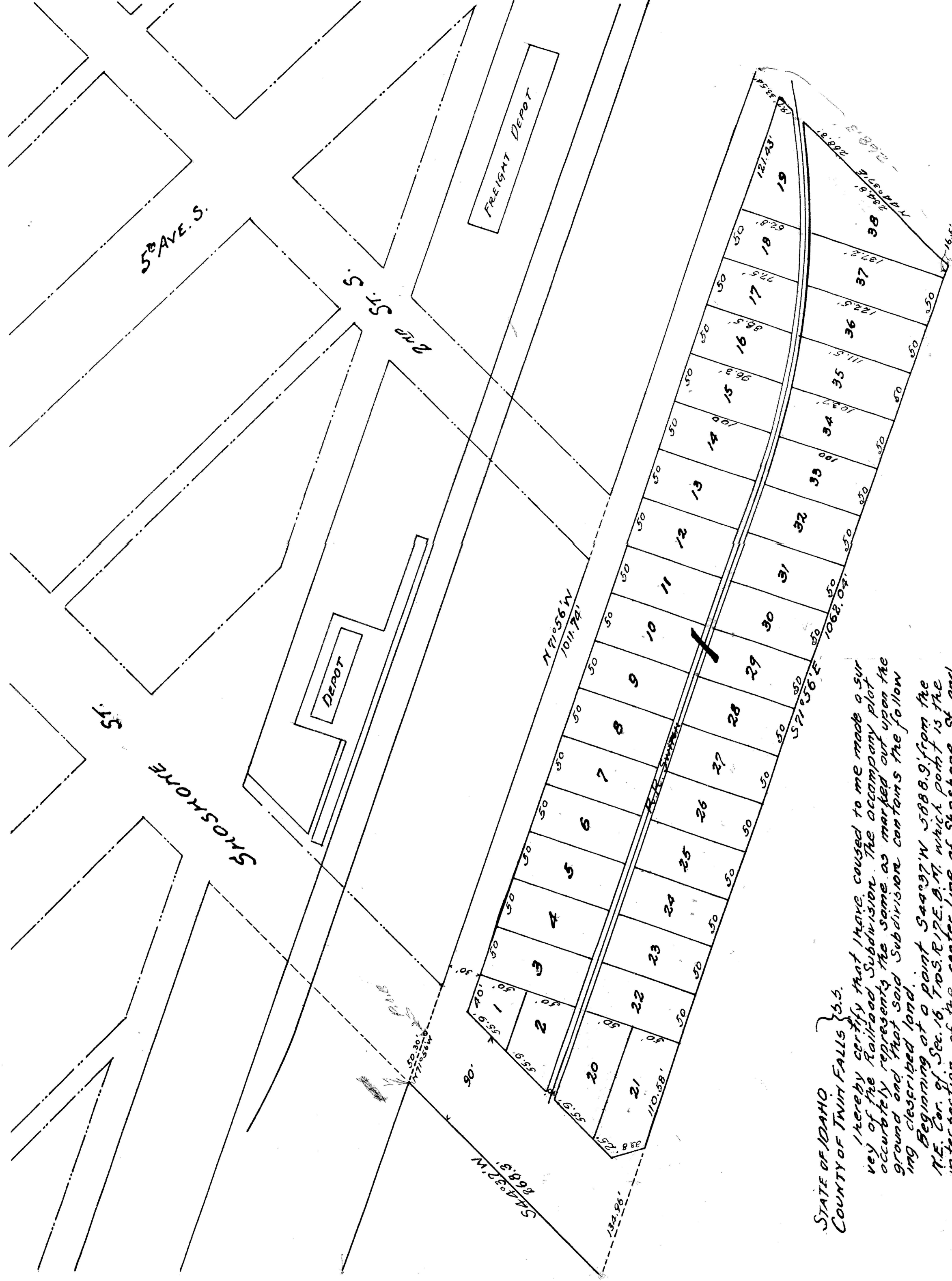


RAILROAD SUBDIVISION
