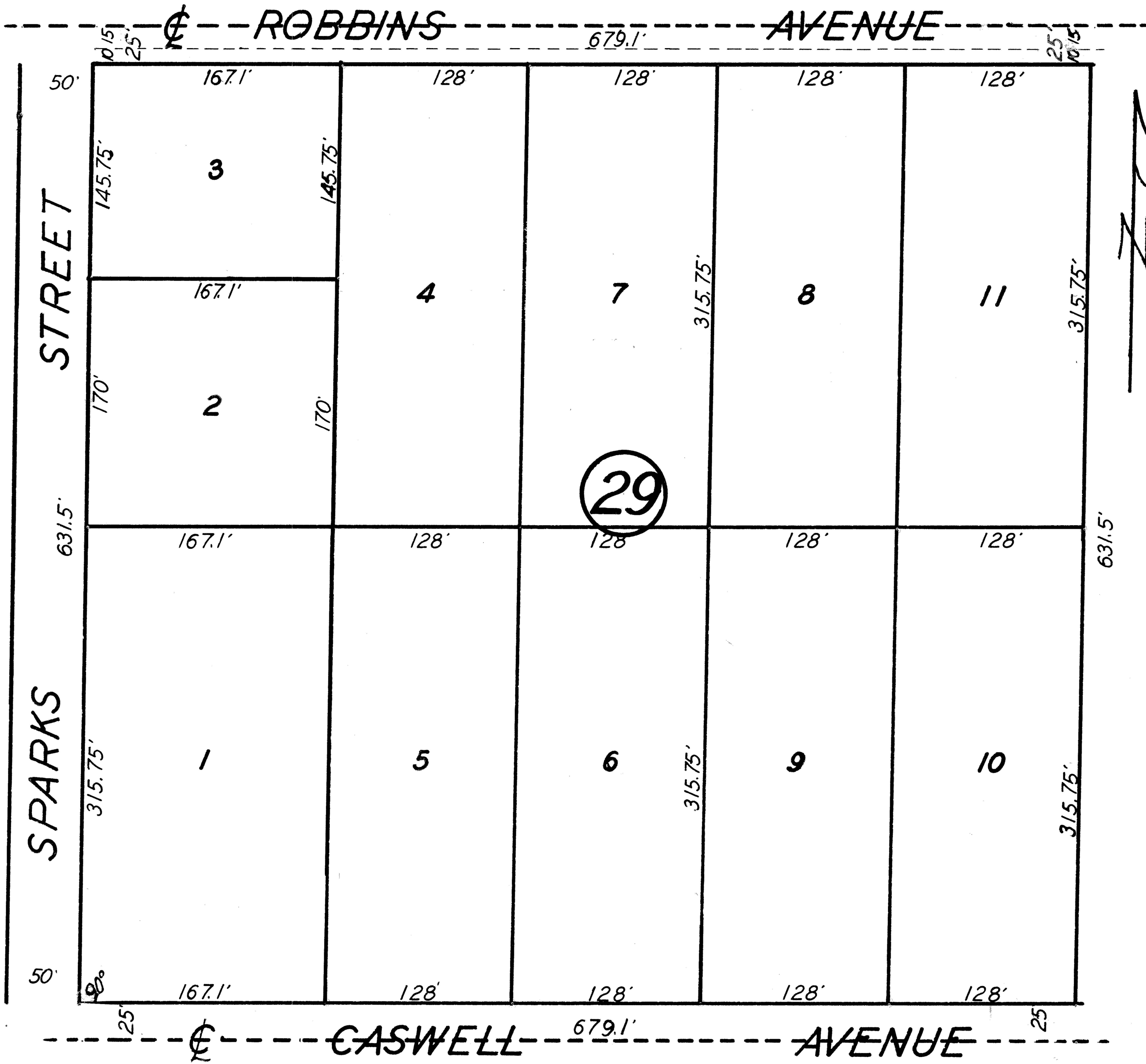




DEDICATION

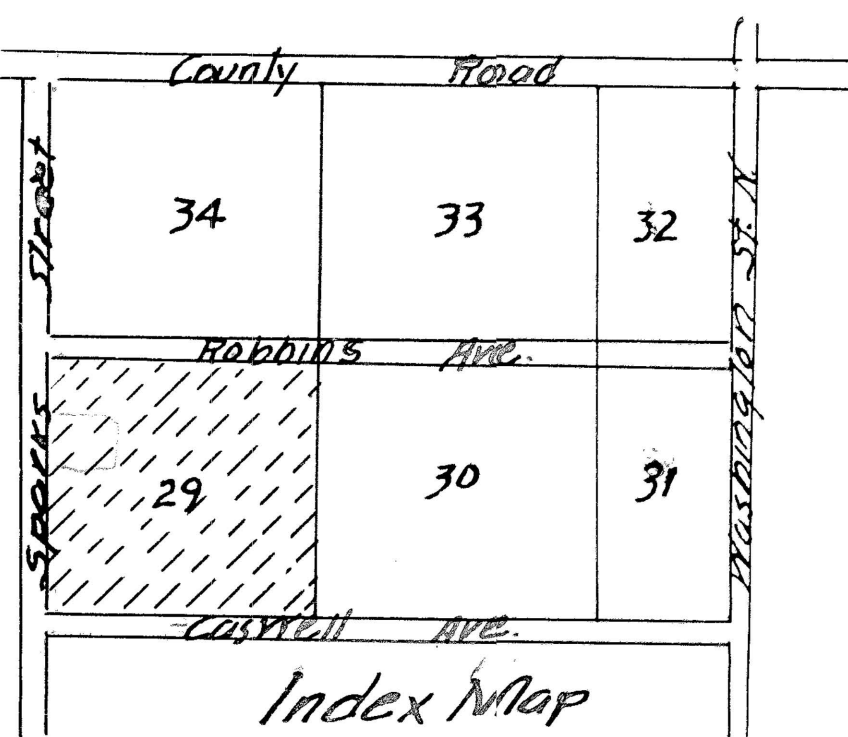
