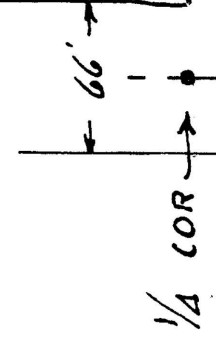

South Washington Addn.

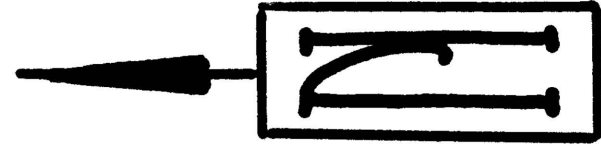

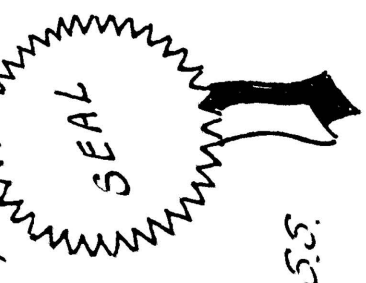
