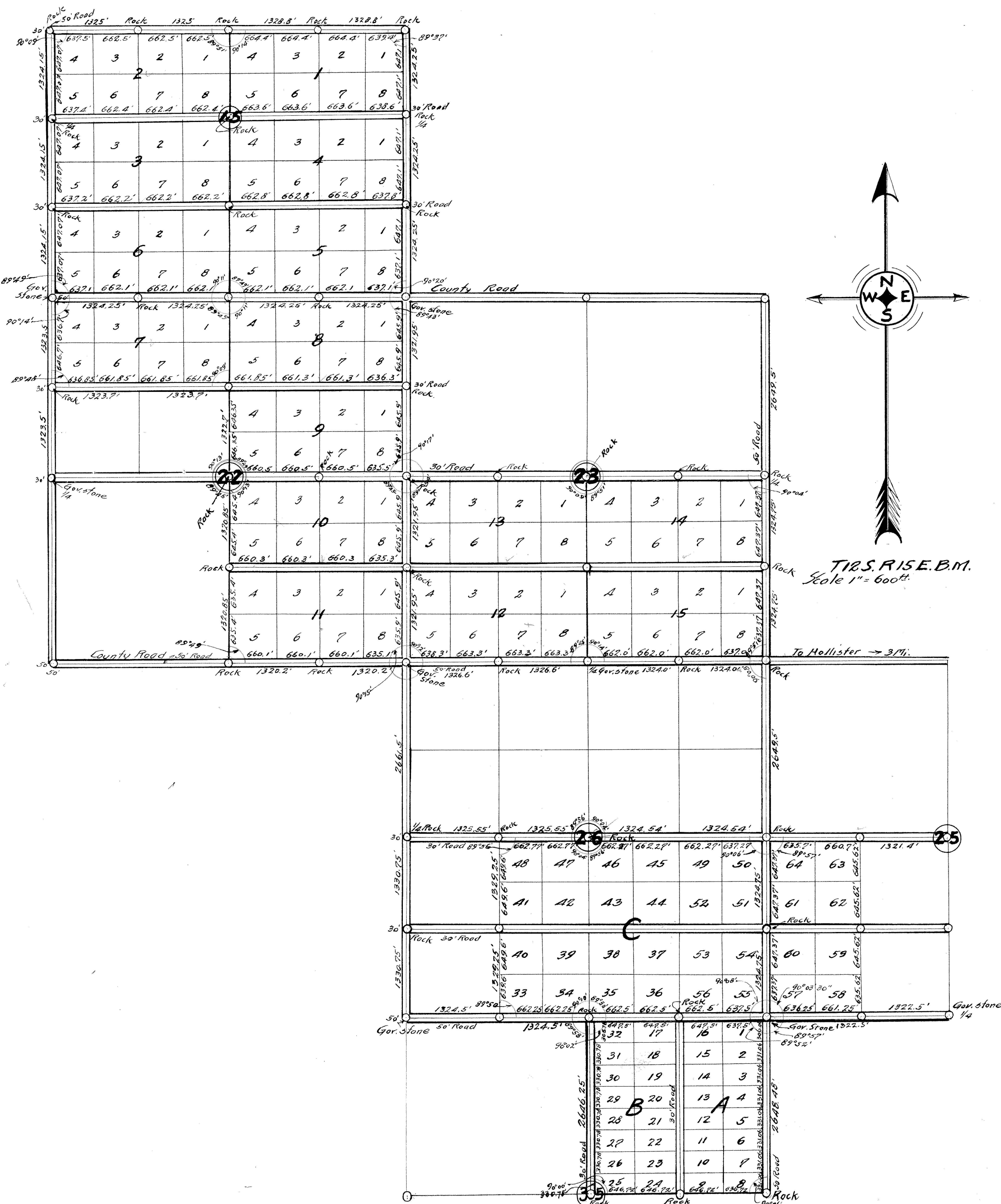

PLAT I.



KNOW ALL MEN BY THESE PRESENTS; That the TWIN FALLS DEEP CREEK ORCHARD COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Idaho, is the owner of the following described land to-wit:- South one half of the North west one quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$), South one half North East one quarter (S $\frac{1}{2}$ NE $\frac{1}{4}$), and the South East one quarter (SE $\frac{1}{4}$) and the Southwest one quarter (SW $\frac{1}{4}$) Section 15, The North half of the North west one quarter (N $\frac{1}{2}$ NW $\frac{1}{4}$), The Northeast one quarter (NE $\frac{1}{4}$) and the southeast one quarter (SE $\frac{1}{4}$) Section 22. The Southwest one quarter (SW $\frac{1}{4}$) and the South east one quarter (SE $\frac{1}{4}$) Section 23. The west one half of the south west one quarter (W $\frac{1}{2}$ SW $\frac{1}{4}$) Section 35. The Northeast one quarter (NE $\frac{1}{4}$) Section 35. The East one half of the South west one quarter (E $\frac{1}{2}$ SW $\frac{1}{4}$), and the South east one quarter (SE $\frac{1}{4}$) Section 26, all said sections lying in Township 12 South, Range 15 East, Boise Meridian, Idaho.

And said corporation does further certify that it has laid out and plotted the above described in five (5) and ten (10) acre tracts more or less as shown on this plat, to be known as PLAT I.

The North half of the North west one quarter (N $\frac{1}{2}$ NW $\frac{1}{4}$), The Northeast one quarter (NE $\frac{1}{4}$) and the southeast one quarter (SE $\frac{1}{4}$) Section 22, the southwest one quarter (SW $\frac{1}{4}$) and the southeast one quarter (SE $\frac{1}{4}$) Section 23, the east half of the southwest one quarter (E $\frac{1}{2}$ SW $\frac{1}{4}$) and the southeast one quarter (SE $\frac{1}{4}$) section 26. The west one half of the southwest one quarter (W $\frac{1}{2}$ SW $\frac{1}{4}$) section 25. The Northeast one quarter (NE $\frac{1}{4}$) Section 35, all said sections lying in T. 12 S. R. 15 E.
