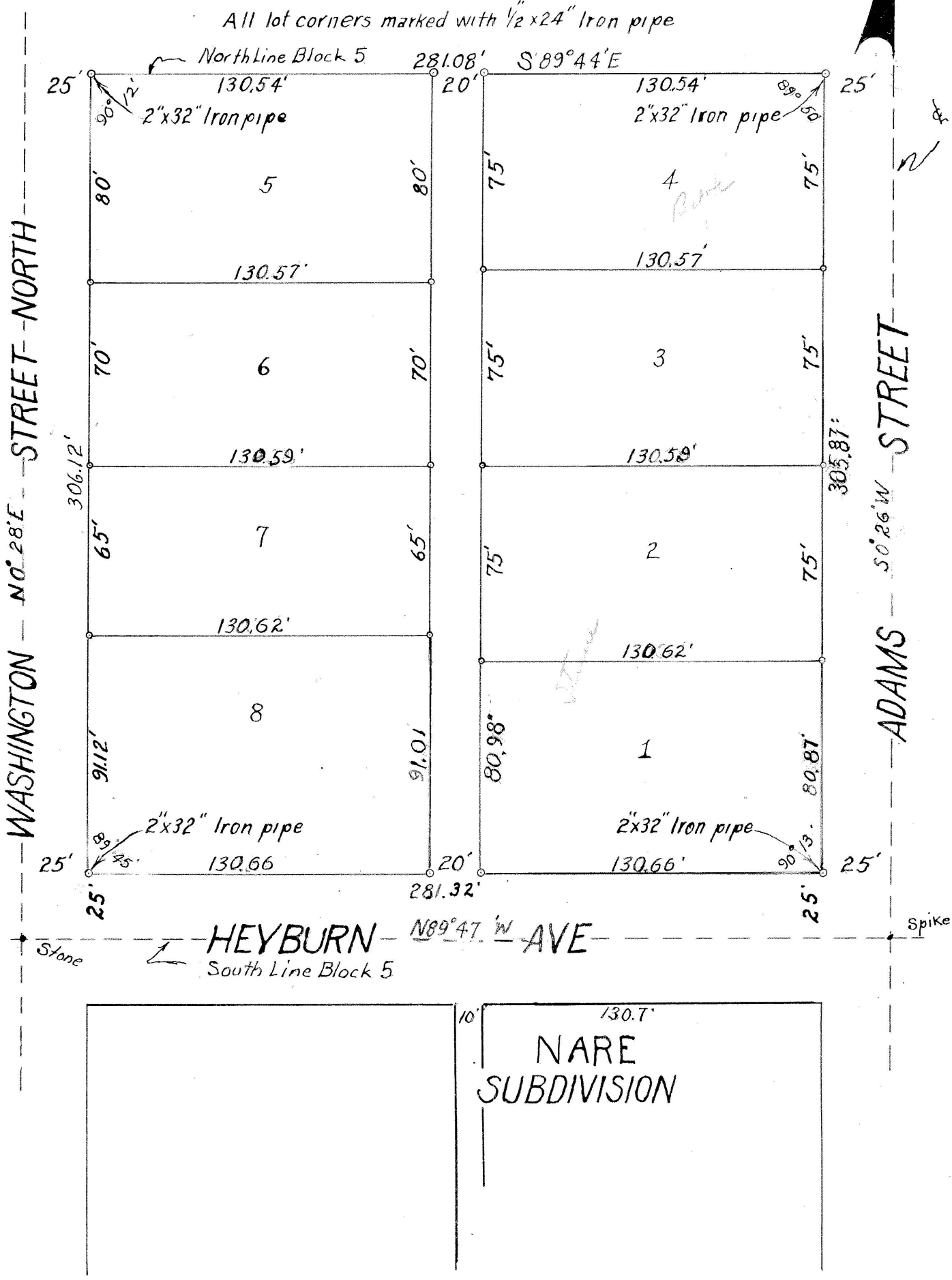


WALTER'S SUBDIVISION

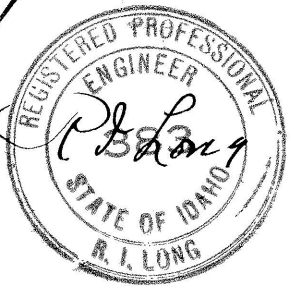
