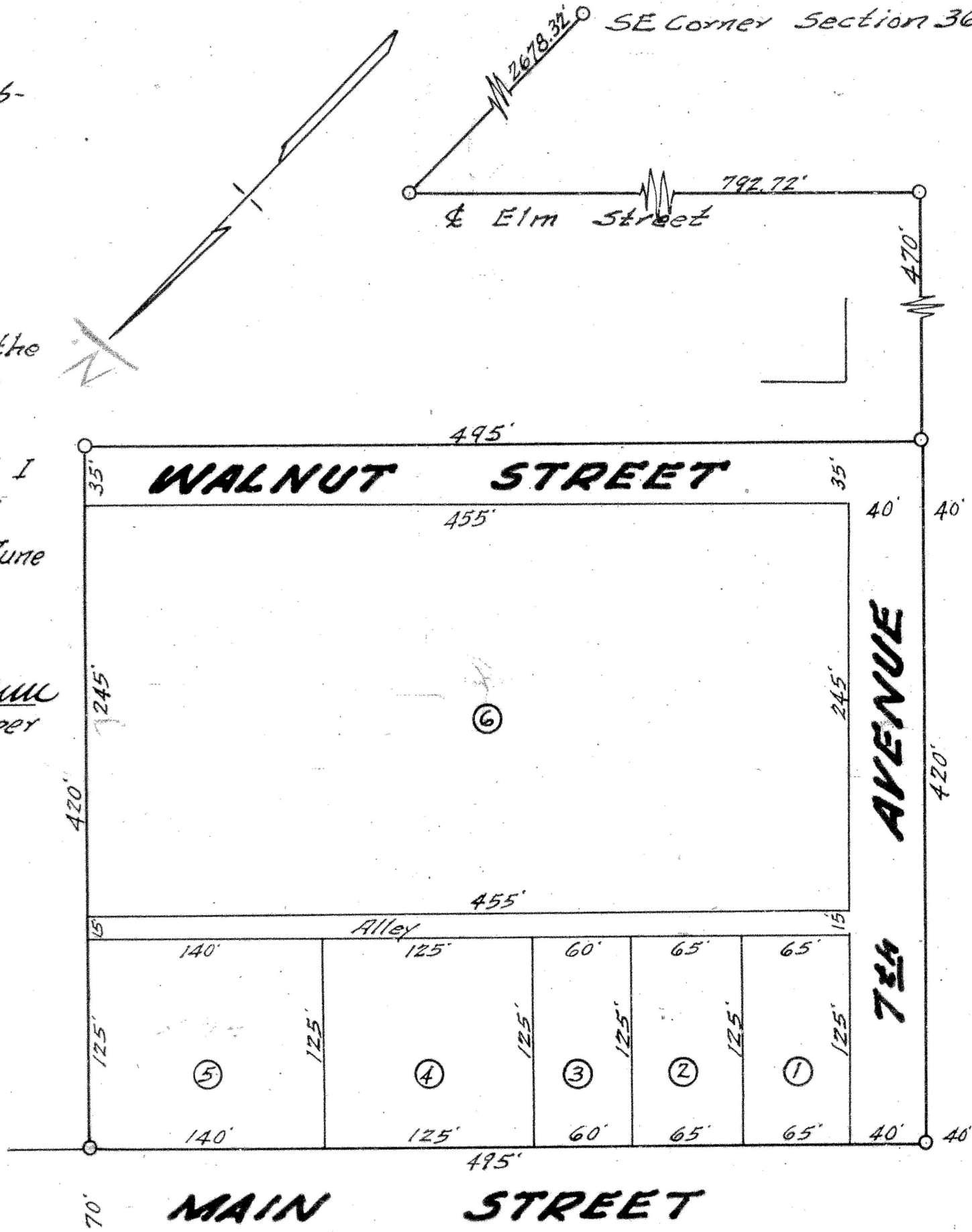
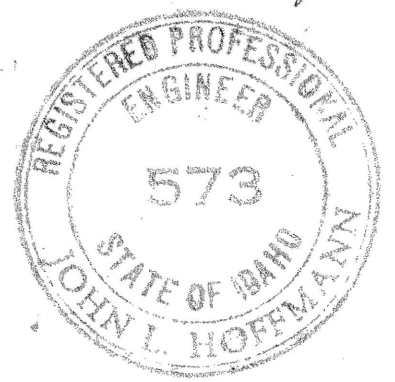

Described as follows: Commencing at a point 2678.32 feet north of the SE corner of section 36, T9S, R14E, BM, thence in a SW direction 792.72 feet on center line of Elm Street; thence NW direction 470 feet on center line of Seventh Avenue to the real point of beginning; thence NW direction 420 feet on the center line of Seventh Avenue; thence NE along a line between Main Street and Tax No. 151, 495 feet; thence SE at right angles 420 feet to a point in the center of Walnut Street; thence SW direction on the center line of Walnut Street 495 feet to the point of beginning.
